Sub: Disclosure under regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, SEBI Circular No. CIR/CFD/CMD/4/2015 dated September 9, 2015 relating to continuous disclosure requirements for listed entities, this is to inform you that at the meeting of the Board of Directors of the Company held today, May 18, 2018 which commenced at 09:00 A.M. and concluded at 9.55 am the following matters have, inter-alia, been taken on record by the members of the board of directors of the Company and the same have been approved by the monitoring agency only to the limited extent of discharging the powers of the board of directors of the Company which has been conferred upon it in terms of the order dated May 15, 2018 of the National Company Law Tribunal, Principal Bench, New Delhi:

1. Issue 7,24,96,036 equity shares of Rs. 2/- each on a preferential / private placement basis to existing lenders of the Company, as per **Annexure 1** pursuant to conversion of loan equivalent to Rs. 144,992,072.
2. Issue 79,44,28,986 equity shares of Rs. 2/- each on a preferential / private placement basis to Bamnival Steel Limited for an aggregate consideration of Rs. 158,88,57,972.
