This is to inform you that the second meeting of the Committee of Creditors ('CoC') of JYOTI STRUCTURES LIMITED (under Corporate Insolvency Resolution Process) was held on Thursday, 14th September 2017 at 11.00 a.m. at IMC Chamber of Commerce and Industry, Babubhai Chinai Committee Room, 2nd Floor, IMC Building, IMC Marg, Churchgate, Mumbai - 400 020.

The e-voting commenced at 3:00 p.m. on 16th September 2017 and was closed at 3:00 p.m. on 18th September 2017.

1. The Resolution Professional ("RP"), Ms. Vandana Garg, had presented the minutes of first meeting of Committee of Creditors and put the same for ratification of the members of the committee of creditors.
