This is to inform you that the Board of Directors of the Company at its meeting held today i.e. 29<sup>th</sup> December, 2017 has considered and approved the following:

1. Issued and allotted 30,000 equity shares of face value of Rs. 10/- each of the Company on preferential basis to Mr. Sarang Panchal (Managing Director and Promoter) at a price of Rs.250/- per share (including premium of Rs.240/- per share), being not lower than the minimum price calculated in accordance with SEBI (Issue of Capital & Disclosure Requirements), Regulations, 2009 and amendment thereto ("ICDR Regulations") (After considering the effects of bonus issue in the ratio of 1:1 allotted on October 13, 2017), pursuant to approval by the members of the Company in the Annual General Meeting held on September 25, 2017, In-principal approval of BSE Limited and in accordance with the ICDR Regulations.

Consequent to the aforesaid allotment, the share capital of the Company stands increased to Rs. 10,02,60,000 divided in 1,00,26,000 equity shares of Rs. 10/- each, fully paid-up.

2. The Board has appointed Ms. Ritu Gupta as Additional Independent/Women Director of the Company w.e.f. 29<sup>th</sup> December, 2017.
