We are pleased to report our highest-ever monthly sales performance in December 2025, reflecting the strength of our diversified product portfolio and strong domestic demand. Robust growth in the tractor, aluminum, and truck wheel segments enabled us to achieve record turnover along with our highest-ever realizations. This performance reinforces our strategic focus on premiumization, operational excellence, and deepening partnerships with key OEM customers.

The Company also achieved its highest-ever average selling price, aided by significantly higher contribution from Tractor, Aluminum, and Truck wheel segments, which witnessed strong volume as well as value growth during the month.

Despite muted export volumes, strong domestic performance and premium segment mix enabled the Company to deliver record turnover and enhanced realizations.

- **Net Turnover:** Rs. 446.59 Cr, as against Rs. 364.74 Cr in December 2024
→ **Growth of 22.44% YoY (Highest Ever)**
- **Gross Turnover:** Rs. 515.87 Cr, as against Rs. 444.81 Cr in December 2024
→ **Growth of 15.98% YoY**
