- (ii) Order from the Office of the Superintendent of CGST, Central Tax, Raipur, Chhattisgarh, demanding tax of ₹ 0.11 crore under Section 74 of the Central Goods and Services Tax Act, 2017 read with the corresponding provisions of Integrated Goods and Services Tax Act, 2017 alleging disallowance of Input Tax Credit for the financial years from 2018-19 to 2021-22 along with applicable interest and a penalty of an equal amount of ₹ 0.11 crore.

The Company is in the process of filing an appeal against the said Orders. There is no material impact on the financials, operations or other activities of the Company due to the above penalties.
