Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (including any modification(s) / amendment(s) /reenactment(s) thereto) and in continuation to Company's disclosure dated February 21, 2025, for the captioned matter we wish to inform you as per the following:

- 1. M/s Eraaya Lifespaces Limited ("the Company"), sought modification and vacation of Hon'ble National Company Law Tribunal (NCLT) Order dated February 13, 2025, by way of an application, which was rejected by the NCLT vide its Order dated March 6, 2025.
- 2. Aggrieved by the NCLT's Order dated March 06, 2025, the Company promptly appealed to the Hon'ble National Company Law Appellate Tribunal, Principal Bench, New Delhi (NCLAT). The NCLAT, vide its Order dated March 26, 2025 (copy received today), recorded the Company's submission that its consent was inadvertently recorded in NCLT's Order dated February 13, 2025. Finding merits in the contention of the Company, the NCLAT disposed of the appeal and directed the NCLT to hear the interim prayers sought in the petition on merits, without being influenced by observations made in its previous Order dated March 6, 2025.
