This is to inform you that I, Chandni Lohar, hereby tender my resignation from the post of Company Secretary & Compliance Officer of the Company due to personal reasons.


I respectfully request the Board of Directors and the Management to relieve me from all the duties, obligations and accountability of my position with immediate effect.
