**Subject: Business Update at the end of Quarter 1 of Financial Year 2025-26 (Q1FY26)**

Dear Sir/ Madam,

Please find below quarterly update of the Company for the quarter ended June 30, 2025.

**1. Revenue From Operations**

- Total revenue from operations for the quarter stood at Rs.885 Crores compared to Rs.786 crore last year reflecting year on year growth of 13%
- The same store sales growth (SSSG) stood at +1% for the quarter (V-Mart at +1% and Unlimited at +1%)
- Normalised for the preponement of Eid to the previous quarter in this year, same-store sales grew by 5% YoY for the quarter (V-Mart at +5% and Unlimited at +5%)

*The above revenue numbers are provisional and subject to review by the Statutory Auditors of the Company.*

**2. Store Opening & Closures**

- The Company has opened 15 new stores and closed 2 stores during the quarter.
- The 15 New stores include Three (3) stores each in Tamil Nadu and Uttar Pradesh, Two (2) stores each in Bihar and Uttarakhand and one (1) store each in Jharkhand, Gujrat, Telangana, Maharashtra and Odisha.
- With this the total number of stores now stands at 510 as at June 30, 2025.
