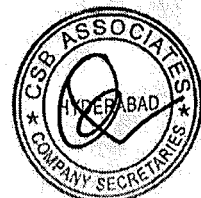

I, C. Sudhir Babu, Practicing Company Secretary having office at # 307, Babukhan Estate, Basheerbagh, Hyderabad - 500001, was appointed as Scrutinizer by the Board of Directors of M/s. - (2) The Company has appointed Central Depository Services Limited (CDSL) as the Agency, for providing the facility of e-voting to the Members of the Company.
- (3) Pursuant to the MCA Circulars the Members of the Company holding equity shares, as on the "cut-off date" i.e., Friday, June 27, 2025 were entitled to vote on the proposed resolutions as set out in the Notice of the Postal Ballot dated May 29, 2025, through e-voting only.
- (4) The e-voting period commenced on Tuesday, July 1, 2025 (9:00 a.m.) and ended on Wednesday, July 30, 2025 (5:00 p.m.) at the e-voting Platform on the designated website of CDSL, e-voting facility was blocked forthwith thereafter.
- (5) Pursuant to the provisions of the Act and Circulars issued by the Ministry of Corporate Affairs, the Company has sent Postal Ballot Notice to its Members whose name(s) appeared in the Register of Members/ List of beneficial owners as received from National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL) and whose e-mail IDs were available with the Company and Depositories, as on the cut-off date i.e., June 27, 2025, through electronic means only and has not dispatched physical notices to any member.

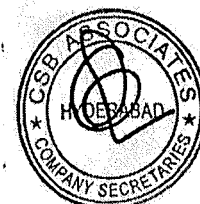

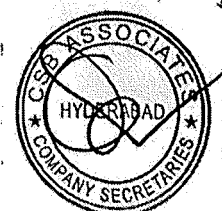
