a. Name of the Opposite Party	Reliance Infrastructure Limited ("Reliance Infra")
b. Court / Tribunal / Agency	Arbitral Tribunal
c. Brief Details of Dispute / Award	The Company filed its claims for an amount of Rs.2,85,40,417/- plus interest & cost of arbitration, before 3 member Arbitral Tribunal, against the Opposite Party arising out of works contract executed by the Company for Reliance Infra. Subsequently, Reliance Infra had filed counter claims against the Company for an amount of Rs 59,82,71,218/- with interest thereon. The Company and Reliance Infra held settlement talks pursuant to which a joint application was filed before the Arbitral Tribunal on 31st July, 2025 vide which both the Parties have submitted to the AT that they have mutually decided to settle the disputes by unconditionally withdrawing their respective claims / counter-claims and terminate the arbitration proceedings. The Arbitral Tribunal has accepted the joint application and accordingly passed an order for termination of the arbitral proceedings on 31st July, 2025.
Expected financial implications, if any.	There is no material financial impact on the Company due to the settlement.
Quantum of Claims, if any	In view of the closure of the proceedings, not applicable.
