दुकानदार को गोली मारने के मामले में तीन पकड़े

नई दिल्ली। उत्तर-पूर्वी दिल्ली के भजनपुरा इलाके में कथित तौर पर जबरन उगाही की रकम देने से इंकार करने पर 25 वर्षीय एक दुकानदार को गोली मारने के आरोप में तीन लोगों को गिरफ्तार किया गया है। पुलिस ने शनिवार को यह जानकारी दी। उन्होंने बताया कि आरोपियों की पहचान नव प्रभात (35), जुनैद (27) और मोहम्मद आसिफ (32) के रूप में हुई है। पुलिस के अनुसार, घटना बृहस्पतिवार को हुई जब पीड़ित अलाउद्दीन अपनी दुकान पर था और तीन लोग वहां पहुंचे और उसे हर हफ्ते 2,000 रुपये देने या गंभीर परिणाम भुगतने की धमकी दी। पुलिस ने बताया कि जब पीड़ित ने इनकार किया, तो जुनैद ने उस पर गोली चला दी और तीनों मौके से भाग गए। हालांकि, अलाउद्दीन गोली लगने के बावजूद बच गया। पुलिस उपायुक्त (उत्तर-पूर्व) संजय कुमार सैन ने कहा कि तकनीकी निगरानी के साथ-साथ अन्य सूत्रों के माध्यम से, आरोपियों के स्थान का पता लगाया गया और शुक्रवार को हमारी टीम ने छापेमारी की और तीनों को यहां कदमपुरी पुलिस से गिरफ्तार किया।

दिल्ली कैंट मामले में चार्जशीट दाखिल

नई दिल्ली। दिल्ली कैंट इलाके में नौ साल की बच्ची से बर्बरता मामले में क्राइम ब्रांच ने चार्जशीट दाखिल कर दी है। एमएम मनु श्री, पटियाला हाउस कोर्ट की अदालत में दाखिल की गई चार्जशीट 400 पन्नों की है। इस पर 31 अगस्त को संबंधित न्यायालय द्वारा विचार किया जाना है। गौरतलब है कि यह केस दिल्ली कैंट पुलिस से पांच अगस्त को क्राइम ब्रांच में स्थानांतरित कर दिया गया था। जिसके बाद पेशेवर और त्वरित जांच के लिए एसीपी संदीप लांबा, एसीपी रिछपाल सिंह, इंस्पेक्टर नीरज, एसआई आशा और एसआई अनुज को शामिल करते हुए एक विशेष जांच दल का गठन किया गया था। मोनिका भारद्वाज, डीसीपी की देखरेख में जांच के दौरान, प्रसंगिक गवाहों की गवाही दर्ज करने के अलावा, वैज्ञानिक, तकनीकी और अन्य साक्ष्य एकत्र किए गए और उनका विश्लेषण किया गया। इसके अलावा, फॉरेंसिक साइंस लेबोरेटरी, रोहिणी के साथ-साथ दिल्ली पुलिस के फॉरेंसिक एक्सपर्ट्स ऑन बायोलॉजी एंड ओडोन्टोलॉजी से सहायता ली गई।

डीसीपी साउथ-ईस्ट डिस्ट्रिक्ट आरपी मीणा ने बताया कि 10 अगस्त को न्यू फ्रेंड्स कॉलोनी में सुखदेव विहार के पास नाले में ट्रॉली बैग में शव होने की सूचना मिली। पुलिस मौके पर पहुंची और काले रंग के बैग से एक पुरुष की लाश बरामद की। लाश काफी गल सड़ चुकी थी। इसलिये शव की शिनाख्त नहीं हो पाई थी। मृतक के दाहिने हाथ पर नवीन नाम का एक टैटू बना हुआ था। पुलिस ने शव मोर्चरी में सुरक्षित रखवा आसपास के इलाके में पूछताछ शुरू की। काफी मशक्कत के बाद मृतक की शिनाख्त नवीन निवासी देवली गांव उम्र 24 वर्ष के तौर पर हुई। 12 अगस्त को पुलिस स्टेशन नेब सराय में उसके लापता होने की शिकायत दर्ज थी।

पत्नी ने ही गुमशुदगी की रिपोर्ट दर्ज करवाई थी

पुलिस जांच में पता चला नवीन के लापता होने की रिपोर्ट उसकी पत्नी मुस्कान ने दर्ज कराई गई थी। उसने बताया था कि पति नवीन 8 अगस्त से लापता है। नवीन की पत्नी कुछ दिन पहले ही किराए के कमरे को खाली कर जा चुकी थी। पुलिस मकान मालिक प्रदीप तक पहुंच गई। उन्होंने बताया कि मुस्कान पिछले डेढ़ महीने से किराए पर थी। 11 अगस्त को वह अचानक कमरा खाली करके चली गई। पुलिस ने मुस्कान

के बारे में जानकारी जुटाई। पता चला कि मुस्कान अपनी मां और दो साल की बेटी के साथ यहाँ रह रही थी। चश्मे वाला एक लड़का मुस्कान के साथ अक्सर दिखाई देता था लेकिन कोई उसका नाम नहीं बता पाया। पुलिस मुस्कान के मोबाइल नंबर की मदद से उस तक पहुंच गई। खानपुर गांव में मुस्कान अपनी मां मीनू उर्फ त्रिसा और 2 साल की बेटी के साथ रह रही थी।

पुलिस को गुमराह करने की हुई कोशिश

मुस्कान ने पुलिस की जांच को गुमराह करने की कोशिश की। उसने बताया कि नवीन दक्षिणपुरी का रहने वाला है। वह पिछले 4-5 साल से नवीन के साथ

रिलेशनशिप में हैं और इस रिश्ते से उसे 2 साल की एक बेटी है। पिछले 7 महीनों से दोनों अलग रह रहे थे। वह देवली खानपुर में अपनी मां मीनू के साथ रहने लगी। 7 अगस्त की रात करीब 11:30 बजे नवीन नशे की हालत में उसके कमरे में आया और उससे झगड़ा करने लगा। नवीन ने मुस्कान को मारा, जिससे उसके मुंह से खून निकलने लगा और उसने पीसीआर कॉल की। पीसीआर वैन आई और वह अपनी मां के साथ मेडिकल जांच के लिए एम्स ट्रॉमा गई। जब वह अपने कमरे में लौटी तो नवीन पहले ही जा चुका था। अगले दिन नवीन के भाई संदीप ने उससे पूछा कि नवीन बीती रात से घर नहीं पहुंचा। इसके बाद उसने थाना नेब सराय में गुमशुदगी की रिपोर्ट दर्ज

कराई। पुलिस ने उसके मोबाइल फोन की जांच की तो कॉल लॉग डिलीट किया जाने का पता चला। पुलिस ने नवीन के लापता होने की सूचना पांच दिन की देरी से बताने के बारे में पूछा। पुलिस ने उसके फोन का सीडीआर प्राप्त कर विश्लेषण किया। जिसमें पता चला कि वह लगातार एक मोबाइल नंबर के संपर्क में थी।

इमारत में लगी थी। सूचना मिलने के बाद दमकल विभाग की 14 गाड़ियां मौके पर

पहुंची। दमकल विभाग की टीम ने एक घंटे की कड़ी मशक्कत के बाद आग पर काबू पाया।

बताया जा रहा है कि संकरी गलियां होने के कारण दमकल विभाग की गाड़ियों को फैक्ट्री तक पहुंचने में थोड़ी परेशानी हुई। बताया जा रहा है कि फैक्ट्री में प्लास्टिक शीट, कागज और गत्ता होने के कारण आग तेजी से लपटें पकड़ने लगी। फैक्ट्री में दिन में ही काम होता है। रात में फैक्ट्री बंद रहती है।
