## Ukraine nuke plant

The Group of Seven (G7) welcomed a mission of the International Atomic Energy Agency (IAEA) to the Zaporizhzhia nuclear power plant (NPP) and called for ensuring safe and unimpeded access to all Ukrainian nuclear facilities, the G7 Non-Proliferation Directors Group said on Monday. Earlier in the day, Mikhail Ulyanov, Russia's permanent representative to international organizations in Vienna, said that the IAEA mission headed by Director General Rafael Grossi was on its way to the Russian-controlled facility.

"The G7 Non-Proliferation Directors Group welcomes the IAEA-led mission announced by

Director General Grossi for August 29, 2022, to address nuclear safety, security and safeguards concerns around the Zaporizhzhia Nuclear Power Plant. We also welcome UN Secretary General [Antonio] Guterres' efforts to provide necessary support to this mission," a statement read.

The G7 non-proliferation directors group also expressed its "full and continued support for the IAEA." "IAEA staff must be able to access all nuclear facilities in Ukraine timely, safely and without impediment, and engage directly, and without interference, with the Ukrainian personnel responsible for operating these facilities, which

must be allowed to carry out its duties without threats or pressure and must be able to acquire information relevant to all the necessary technical elements pertaining to nuclear safety and security at the installations," the statement added.

The Zaporizhzhia NPP, located on the left bank of the Dnieper River, is the largest nuclear power plant in Europe in terms of the number of units and output. Since March, the facility and surrounding areas have been controlled by the Russian military. The NPP has recently been targeted by multiple shelling, raising international concerns over a possible nuclear accident. Russia and Ukraine blame each other for the shelling incidents.

Given the critical energy situation that could lead to a major crisis, Germany has decided not to supply weapons to Ukraine that could strike the Russian territory, German Chancellor Olaf Scholz said. "I think everyone else should follow this principle," Scholz said, making references to a similar decision that American President Joe Biden made earlier. Washington ordered Kyiv not to use long-range weapons to attack the Russian territory. However, Ukrainian Defence Minister Oleksiy Reznikov said that Kyiv could use such weapons to "de-occupy the temporarily occupied territories of Ukraine".

On August 19, Scholz said that Germany was

supplying Ukraine with a lot of weapons. "Germany will help Ukraine as long as necessary, but there should not be an escalation of the conflict. This is the basic principle," he added.

Natural gas prices have surged as Russia has reduced or cut off natural gas flows to a dozen European Union countries, worsening inflation and raising the risk that Europe could plunge into recession. Outgoing UK Prime Minister Boris Johnson said in an op-ed that a few coming months will be tough for the British due to high energy prices. "Our energy bills are going to be eye-watering," he said, adding "for many of us, the cost of heating our homes is already frightening." According to

Johnson, the beginning of Russia's special operation in Ukraine significantly affected the energy markets.

A British citizen Lewis Ford, an IT consultant and volunteer with Don't Pay UK, has decided to stop paying his energy bills from October 1 this year. He has said, "I will stop paying my energy bills as part of Don't Pay UK." That's when an 80 per cent increase on current rates will kick in, the British energy regulator confirmed last week. He is among 120,000 people who have joined this movement, which aims to elevate the voices of ordinary residents of the United Kingdom who are scared for their futures while energy companies reap enormous profits.

He revealed that he

received a liberal pay hike but the prices of food and energy also leapt drastically. "Our nursery provider increased its prices. Everything went up. So we didn't actually feel the pay rise. Practically every month we run out of money. We are still living pay cheque to pay cheque. But every time we try to save any money, it just gets chewed up by energy bills, and we know it's going to get worse. I'm already in debt to my energy company, before prices are set to go higher on October 1. That's because every three months in England, Scotland and Wales, the maximum amount suppliers can charge is adjusted," he explained.

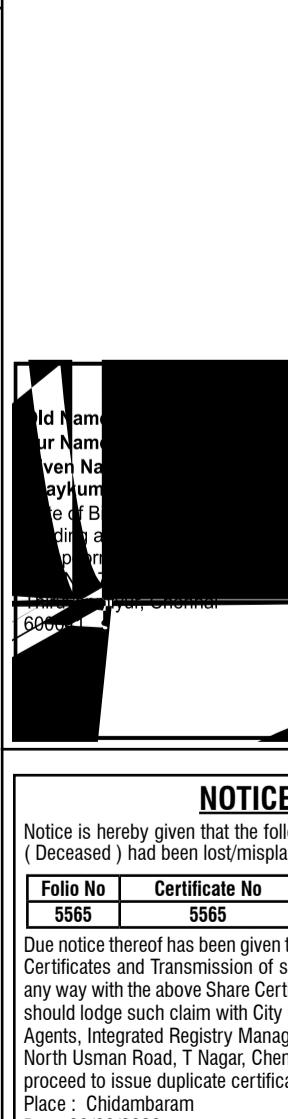
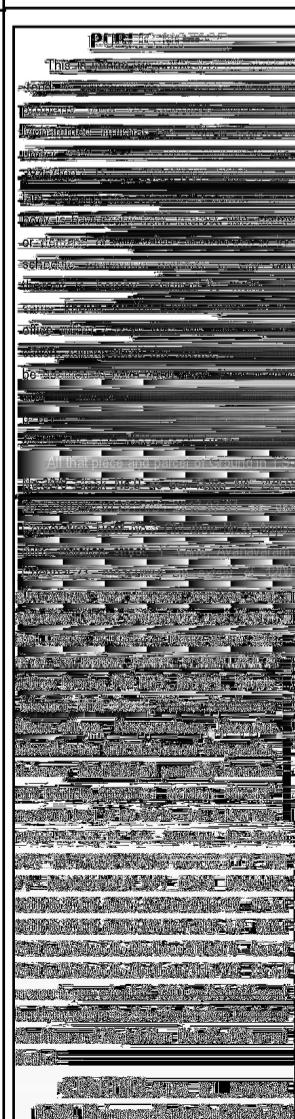
