- The e-voting period commenced on 27th September, 2020 (9.00 a.m. IST) and ended on 29th September, 2020 (5.00 p.m. IST).
- Facility of Voting through Ballot Papers was made available at the AGM and the Ballot papers were distributed for voting at the meeting.
- Members attending the AGM, who have not voted using remote e-voting, were allowed to vote through the Ballot Papers.

Mr. Mohit Gurjar, Practising Company Secretary, who is also the Scrutinizer for the e-voting process, was appointed to act as the Scrutinizer to scrutinize the polling process in a fair and transparent manner.

Thereafter, the Chairman took the Item nos. 1 to 5 of the Notice and explained the objectives of each item of the Notice and invited queries from the Members.

All queries raised were answered by the Chairman.

The Chairman then ordered the voting through ballot papers at the venue of AGM on all the resolutions set in the notice of AGM.
