SCRUTINIZER'S REPORT ON THE POSTAL BALLOT PROCESS CONDUCTED THROUGH REMOTE EVOTING:

Dear Sir,

I, Sahib Chauhan, Proprietor of M/S Sahib & Co, Chartered Accountant, and a whole time Practicing Chartered Accountant was appointed as a Scrutinizer by the Board of Directors **of Pix Transmissions Limited** for scrutinizing postal ballot which was conducted only through electronic means in respect of the resolution contained in the Notice dated 13th August, 2021 in a fair and transparent manner and for ascertaining the requisite majority for the resolution proposed to be passed with respect to the provisions of Sections 108 and 110 of the Companies Act, 2013 ('the Act') read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014 (as amended) and in terms of the General Circular No.14/2020 dated 8th April, 2020 and General Circular No. 17/2020 dated 13th April, 2020 (the "MCA Circulars"), issued by the Ministry of Corporate Affairs, Government of India (the "MCA") and Regulation 44 of Securities and Exchange Board of India (Listing Obligations & Disclosure Requirements) Regulations, 2015, as amended, ["SEBI Listing Regulations"] on the resolutions as set-out in the notice of Postal Ballot.

I submit my report as under:

1. The Management of the Company is responsible to ensure the compliance with the requirements of the Act and Rules made thereunder including MCA Circulars issued by the MCA in view of the current extraordinary circumstances due to COVID-19 pandemic requiring social distancing and SEBI Listing Regulation, relating to postal ballot process conducted through electronic means.
2. The Company has appointed "National Security Depository Limited" ("NSDL"), as the Agency, for providing the facility of remote e-voting to the Members of the Company. NSDL has provided a system for recording the votes of the shareholders electronically.
3. My responsibility as Scrutinizer is restricted to make Scrutinizers' Report of the votes cast "For" or "Against" the resolutions stated in the Notice of Postal Ballot.

4. Pursuant to the MCA Circulars the Members of the Company holding equity shares, as on the "cut-off date" i.e. Friday August 27, 2021 were entitled to vote on the proposed resolution as set out in the Notice of Postal Ballot dated 13th August, 2021, through remote e- voting only.

5. The remote e-voting period commenced from Wednesday, September 1, 2021 (9.00 A.M.) and ended on Thursday, September 30, 2021 (5.00 P.M.) at the e-voting platform on the designated website of National Security Depository Limited i.e. (www.evoting.nsdl.com). E-voting facility was blocked forthwith thereafter.

6. Pursuant to the provisions of the Act and MCA Circulars issued by Ministry of Corporate Affairs, the Company has sent Postal Ballot notice(s) to its Members whose name(s) appeared in the Register of Members/ List of beneficial owners received from National Securities Depository Limited /Central Depository Services (India) Limited as on the Cut-off date i.e. Friday August 27, 2021 and whose e-mail IDs was available with the Company and Depositories, through electronic means only and has not dispatched physical notices to any member. Further the Company vide the Postal Ballot notice dated August 13, 2021, had also requested its shareholders to register their email addresses with the Registrar and Transfer Agent of the Company.

7. As stated in Sub-rule 3 of Rule 22 of Companies (Management and Administration) Rules, 2014 as amended from time to time & MCA circulars, on September 1, 2021, public notices were published by the Company in Financial Express ("English Newspaper") and in "Loksatta" ("Marathi Newspaper") informing about the completion of dispatch of Postal Ballot notices to its shareholders through electronic means, along with all requisite document.

8. I monitored the process of electronic voting (i.e. remote e-voting) through the scrutinizer's secured link provided by NSDL through its designated website.

9. Due to COVID-19, pandemic and nationwide lockdown announced by the Central/State Government, physical ballot was not dispatched, and provisions of MCA Circulars dated 8th April 2020 and 13th April, 2020 were adhered. Therefore, neither the Company nor I have received any postal ballot (s).

10. After completion of e voting, the votes cast by the members through electronic means were unblocked on Friday, 1st October, 2021.

11. Votes casted by the members through remote e-voting, were reconciled with the records maintained by the Registrar and Transfer Agent of the Company and authorizations lodged with the Company.

12. I, have emailed all the registers/other documents and records related to e-voting for the safe custody to the Company Secretary.

13. After ascertaining the votes casted by remote e-voting, I hereby submit the result as under:

1. ORDINARY RESOLUTION:

“RESOLVED THAT pursuant to the provisions of Sections 139, 142 and other applicable provisions, if any, of the Companies Act, 2013 read with the Companies (Audit and Auditors) Rules, 2014 as amended from time to time or any other law for the time being in force (including any statutory modification(s) or amendment(s) thereto or re-enactment thereof for the time being in force) and upon recommendations of the Audit Committee, M/s MSKA & Associates, Chartered Accountants, (Firm Registration No. 105047W) be appointed as Joint Statutory Auditors of the Company, to hold office until the conclusion of the 40th Annual General Meeting of the Company, at a remuneration of Rs. 9.75 Lakhs per annum (exclusive of taxes and reimbursement of out of pocket expenses as may be incurred during the audit).

RESOLVED FURTHER THAT Mr. Amarpal Sethi, Chairman & Managing Director, Mr. Karanpal Sethi, Director and Mr. Shybu Varghese, Company Secretary be and are hereby severally authorized to take such necessary steps to give effect to this resolution.”
