NOTE:
 1) The above unaudited financial results have been reviewed by the Audit Committee and approved by the Board of Directors of the Company in their respective meetings, held on October 31, 2025. The Statutory Auditors of the Company have issued unmodified report on the above results.
 2) The above unaudited financial results of the Company have been prepared in accordance with the Indian Accounting Standards (IND AS) prescribed under section 133 of the Companies Act, 2013 (the "Act") read with relevant rules issued thereunder, other accounting principles generally accepted in India and guidelines issued by the Securities and Exchange Board of India.
 3) As per Indian Accounting Standard (Ind AS) 108 'Segment Reporting', the business of the Company mainly comprises sale of "Batteries" which has been identified as a single reportable segment.
 4) During the six months period ended September 30, 2025, the Company revised its accounting estimates with respect to depreciation. This includes a change in the method of depreciation from the Written Down Value (WDV) method to the Straight Line Method (SLM), the removal of residual value for certain assets and an increase in the useful life of certain existing assets based on a technical evaluation. As a result, the depreciation charge has increased by INR 29.78 lakhs for the quarter and expected to increase by INR 55.14 lakhs for the financial year.
 5) The Battery Waste Management Rules, first notified in 2022 and as amended from time to time, are issued by the Ministry of Environment, Forest and Climate Change (MoEFCC). These rules aim to regulate the collection, recycling, and disposal of battery waste in India under the Extended Producer Responsibility (EPR). These regulations have significant implications for entities involved in the manufacture, import, sale, and recycling of batteries. Furthermore, our Company along with other battery manufacturers has already made representations to MoEFCC regarding the practical challenges and concerns related to waste collection and the associated costs. Further guidance or clarification from the Ministry is awaited. Consequently, the company is unable to reliably estimate the range of outcomes and the potential impacts of these rules. The Company will continue to assess its ability to measure the obligation as and when further guidance/details are available.
 6) The shareholders of the Company, in the Annual General Meeting (AGM) held on September 24, 2025, approved final dividend of ₹9.42 per equity share for the financial year ended March 31, 2025. As of September 30, 2025, the declared dividend has not been disbursed to the eligible shareholders and has been presented under "Other Current Financial Liabilities".
