

I, **Vishal Davda, Advocate (Sanad No. G/2775/2023)** have been appointed by the Hon'ble National Company Law Tribunal, Ahmedabad Bench - II ("NCLT") vide its order dated 14th October, 2025 ("Order") as the Scrutinizer for the purpose of scrutinizing the remote e-voting process and e-voting at the NCLT convened meeting of the Unsecured Creditors of Ecoplast Limited (hereinafter referred to as "the

Company") held through VC/OAVM on Friday, 28th November, 2025 at 03:30 P.M, pursuant to Section 108 of the Companies Act, 2013 ("Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, read with the applicable general circulars issued by Ministry of Corporate Affairs ("MCA") and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Master Circular No. SEBI/HO/CFD/POD-2/P/CIR/2023/93 dated 20th June 2023 ("SEBI Scheme Circular") and other applicable circulars issued by SEBI, and SS-2, on the resolution seeking approval of the Unsecured Creditors of the Company to the Scheme of Amalgamation of Kunal Plastics Private Limited with Ecoplast Limited and their respective shareholders ("Scheme"), in terms of the Notice dated 17th October, 2025, convening the said Meeting.

As mentioned in the Notice, the proceedings of the Meeting were deemed to be conducted at the registered office of the Company located at N H Road No. 8, Water Works Cross Road, Abrama, Valsad, Gujarat - 396001, India and the same was deemed to be the venue of the NCLT-convened Meeting.

The Notice of the Meeting was sent by e-mail to all the Unsecured Creditors of the Company, whose names appeared in the Statutory Auditor's certificate certifying the list of unsecured creditors as on 31st March, 2025.

I do hereby submit my report as under:

- i. The Company had appointed Central Depository Services (India) Limited ("CDSL") as the agency for providing facility to its Unsecured Creditors to exercise their right to vote on the resolution proposed to be considered at the

Meeting by electronic means through (i) remote e-voting prior to the Meeting; or
(ii) e-voting during the Meeting.

- ii. CDSL had provided a system for recording the votes of the Unsecured Creditors electronically through remote e-voting prior to the Meeting as well as e-voting at the Meeting on the item of business sought to be transacted at the Meeting of the Unsecured Creditors of the Company, which was held on 28th November, 2025 at 03:30 P.M.
- iii. The Management of the Company is responsible for ensuring compliance with the requirements of the Act, the Rules made thereunder, the applicable general circulars issued by MCA, and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 relating to voting through remote e-voting prior to the Meeting and e-voting at the Meeting on the resolution contained in the Notice of the Meeting dated 17th October, 2025.
- iv. The Company had provided remote e-voting facility and e-voting facility during the Meeting through CDSL to its Unsecured Creditors as on the cut-off date i.e., 31st March, 2025.
- v. My responsibility, as a Scrutinizer for the voting process (through remote e-voting and e-voting at the Meeting) was restricted to scrutinizing the voting process in a fair and transparent manner and to prepare a consolidated Scrutinizer's Report of the votes cast by the Unsecured Creditors of the Company "in favour" or "against" the resolution stated in the Notice of the Meeting dated 17th October, 2025, based on the reports generated from the e-voting system provided by CDSL.
- vi. The Company had published newspaper advertisements in *Indian Express* (English edition) and *Financial Express* (Gujarati edition) regarding holding of

- vii. The remote e-voting period commenced on Tuesday, 25th November, 2025 at 9.00 A.M. (IST) and ended on Thursday, 27th November, 2025 at 5.00 P.M. (IST).
- viii. At the Meeting of the Unsecured Creditors of the Company held through VC/OAVM, on Friday, 28th November, 2025, the facility to vote electronically was provided to those Unsecured Creditors who were attending the Meeting through VC/OAVM but had not exercised their votes through remote e-voting.
- ix. After completion of the e-voting process at the Meeting, the votes cast through remote e-voting as well as during the Meeting were unblocked and downloaded from the e-voting website of CDSL (<https://www.evotingindia.com>) on November 28, 2025 around 03:53 P.M.
- x. I first counted the votes cast through remote e-voting prior to the Meeting and e-voting at the Meeting and reconciled them with the records maintained by CDSL.
