Additionally, and in compliance with SEBI Circular No. SEBI/HO/ISD/ISD-PoD-2/P/CIR/2025/55 dated April 21, 2025, regarding the automation of trading window closure at the ISIN level, all Promoters, Promoter Group Directors, Key Managerial Personnel (KMPs), Designated Persons/Employees, Connected Persons, and their Immediate Relatives shall not be permitted to sell or otherwise deal in the securities of the Company during the period starting from January 01<sup>st</sup>, 2026, and continuing until 48 hours after the Unaudited Financial Results (Standalone and Consolidated) for the Third quarter ended December 31, 2025, become generally available.

The Trading Window shall open 48 hours after the Unaudited Financial Results (Standalone & Consolidated) for the 3<sup>rd</sup> quarter ending on December 31<sup>st</sup>, 2025, become generally available.

All the Promoters and Promoter Group Directors, KMPs, Designated Persons/Employees, Connected persons, Fiduciaries and their immediate relatives, directly or indirectly, are prohibited from dealing in the shares of the Company either directly or indirectly during this period of Closure of Trading Window.

The date of the meeting of the Board of Directors to approve the unaudited Standalone Financial Results of the Company for the 3<sup>rd</sup> Quarter ending on 31<sup>st</sup> December, 2025 will be informed in due course.
