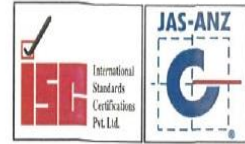
- The Company had, vide its email dated **29th July 2025**, formally informed CARE of its decision not to continue with the rating engagement and had requested withdrawal of the credit rating exercise with immediate effect. Subsequently, the Company received a response dated **07th August 2025** from CARE representatives and duly submitted the documents as requested (copy of the trailing email correspondence is enclosed).
- The Company had also submitted all requisite details, including the **No Objection Certificate (NOC)** from its existing bankers, for closure of the engagement and had requested CARE Ratings Limited to intimate any outstanding dues, if any.
- Despite the aforesaid communications and compliances, CARE Ratings Limited has proceeded to publish the said credit rating, which does not reflect the Company's current financial position or credit profile and has resulted in a misleading perception in the public domain.

In view of the above, the Company hereby clarifies that the credit rating assigned by CARE Ratings Limited **should not be considered or relied upon by any stakeholders.**
