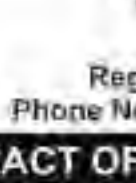

2.	The aforesaid financial results of the Company were reviewed by the Audit Committee and approved by the Board of Directors at their respective meeting held on January 11, 2026. The Statutory Auditors of the Company have provided their limited review report on these financial results with an unmodified opinion.					
3.	The Consolidated financial results includes results of the Company's subsidiaries in United Arab Emirates, India and step down subsidiary in France.					
4.	The figures of the previous period/year are classified, regrouped and reclassified whether necessary so as to make them comparable with current period's figures.					
5.	The statutory auditor of the Company undertakes a limited review of the subsidiaries of which accounts are consolidated with the Company.					
6.	Belrise Defence and Aerospace Private Limited, a wholly owned subsidiary of the Company, has incorporated Belrise SOM, a Simplified Joint Stock Company (Simpli-Matrimonial Company), on November 19, 2025, under the laws of France. It is wholly owned subsidiary. Accordingly, Belrise SOM is a step down subsidiary of the Company.					
7.	On November 21, 2025, the Government of India notified the four Labour Codes i.e. Code on Wages, 2019, the Industrial Relations Code, 2020, the Code on Social Security, 2020, and the Occupational Safety, Health and Working Conditions Code, 2020 - consolidating 29 existing labour laws. The Ministry of Labour & Employment published draft Central Rules and FAQs to assist in assessment of the financial impact due to changes in regulations.					
	The Company has assessed and disclosed the incremental impact of these changes on the basis of latest opinion obtained and the best information available, consistent with the guidance provided by the Institute of Chartered Accountants of India. Considering the materiality and regulatory-driven, non-recurring nature of the impact, the Company has presented such incremental impact as Statutory impact of new Labour codes under Extraordinary items in the Standalone Statement of Profit and Loss for the period ended December 31, 2025. The incremental impact consolidated total of Rs. 47.65 Million and Consolidated Assets of Rs. 16.48 Million primarily stems due to change in wage limitation.					
	The Company continues to monitor the finalization of Central / State Rules and Notifications from the Government in union aspects of the Labour Code and would observe appropriate accounting effect on the basis of such developments as needed.					
8.	There is no deviation towards utilization of proceeds of IPO for the quarter ended December 31, 2025.
