## **Artemis' Consolidated Revenue from Operations up 17.2% in Q3 (YoY); EBITDA up 12.5%; Net Profit up 7.9%**

February 02, 2026: The Board of Directors of Artemis Medicare Services Ltd today approved the company's financial results for the 3<sup>rd</sup> quarter for the financial year 2025 – 26.

For the quarter ended December 31, 2025 Artemis Medicare Services Ltd, on a consolidated level, registered a revenue from operations of Rs 27,235 Lacs, an increase of 17.2% over the same period last fiscal year.
