Holiday Inn Chennai OMR IT Expressway, BHVL's first hotel through its subsidiary SRP Hotel Ventures Limited in Chennai which commenced operations in April 2017 with 202 keys.

The Company will now add over 500 new keys across three properties in Chennai including Courtyard by Marriott at Chennai World Trade Center, Grand Hyatt Chennai ECR and JW Marriott Chennai OMR. Brigade Group had already acquired lands for these projects to create hospitality destinations in Chennai.

- Grand Hyatt Chennai ECR will be a premier resort with approximately 211 guest rooms.
