70-year-old father donates kidney to save daughter at AINU

Chennai, Jan 31:

In a moving example of parental devotion and medical expertise, the Asian Institute of Nephrology and Urology (AINU),

Chennai, successfully performed a live-related renal transplant, where a 70-year-old father donated his kidney to his 31-year-old daughter suffering from End-Stage Renal Disease (ESRD).

The patient's health issues began three years ago in Malaysia, with early symptoms like swelling and hypertension going untreated. By December 2024, when she reached AINU, she was critically ill with CKD Stage 5, severe fluid overload, and life-threatening anaemia. Emergency dialysis was initiated, followed by long-term stabilization. During transplant evaluation, she was also diagnosed with tuberculosis, which required six months of treatment before clearance for surgery.

After extensive counselling, a transplant

Chennai, Jan 31:

Amar Seva Sangam, a leading organisation in disability management, has launched one of India's largest Sensory Parks at its Ayikudi centre in Tenkasi district, Tamil Nadu. Spread across five acres, the park has been developed with the support of the Australian Consulate in Tamil Nadu and aims to strengthen inclusive, community-based rehabilitation for persons with disabilities.
