We wish to inform you that pursuant to the Resolution Plan and Scheme of Arrangement involving the merger of M/s. String Metaverse Limited into Bio Green Papers Limited, as approved by the Hon'ble National Company Law Tribunal (NCLT) Hyderabad vide its order dated 28th May, 2024, the capital structure of the Company was significantly reorganized.

As a result of the capital restructuring, the post-reduction capital stood at 9,60,866 equity shares of ₹10/- each. In addition, 9,60,00,000 fully paid-up equity shares of ₹10/- each were allotted to the shareholders of String Metaverse Limited pursuant to the approved merger scheme. Due to rounding adjustments and the reorganization process of the said restructuring 470 (Four Hundred Seventy only) equity shares arose as fractional entitlements which could not be allotted to individual shareholders and were therefore transferred to a Trustee account.

We hereby inform you that these 470 (Four Hundred Seventy only) fractional shares were sold on this Monday 02nd June, 2025, at an average price of ₹155.55 (Rupees One Hundred Fifty-Five and Fifty-Five Paise only) per share. The proceeds from the sale shall be distributed/transferred to the respective eligible shareholders in due course. A separate disclosure will be submitted confirming the completion of such disbursement.
