SC sets 3-month deadline for Telangana Speaker to decide on 10 BRS MLAs’ disqualification

Oppn party welcomes verdict, attacks Rahul; Cong hits back

NEW DELHI, JULY 31 /-- / The Supreme Court on Thursday directed the Telangana Assembly Speaker to decide within three months the disqualification petitions against 10 BRS MLAs who had switched allegiance to the ruling Congress, saying political defections have the power to disrupt democracy if not curbed. The apex court held that the Speaker acts as a tribunal while deciding the pleas for disqualification under the Tenth Schedule of the Constitution and consequently does not enjoy "constitutional immunity" against judicial scrutiny. The Tenth Schedule of the Constitution deals with provisions on disqualification on the grounds of defection. Asking the Speaker to decide the disqualification pleas within three months, a bench headed by Chief Justice B R Gavai said: "If we do not issue any directions, it will amount to the Speaker to repeat the widely criticised situation of 'operation successful,

patient dead'." "Political defections have been a matter of national discourse. If not curbed it has the power to disrupt democracy," the CJI said while reading out the judgment. The Supreme Court said it is for Parliament to devise a mechanism to deal with the delay at the end of speakers in deciding disqualification pleas. "Though we do not possess any advisory jurisdiction, it is for Parliament to consider whether the mechanism of entrusting the Speaker/Chairman the important task of deciding the issue of disqualification on the grounds of defection is serving the purpose of effectively combating political defections or not," it said. "If the very foundation of our democracy and the principles that sustain it are to be safeguarded, it is to be examined whether the present mechanism is sufficient or not. At the cost of repetition, we observe that it is for Parliament to take a call on that," the

verdict said. It allowed appeals filed by Bharat Rashtra Samithi (BRS) leaders, including Padi Kaushik Reddy seeking a direction to the speaker to expeditiously decide disqualification petitions against the defected MLAs. The bench set aside the November 22, 2024 decision of the Telangana High Court's division bench which had interfered with a prior order of a single judge. "We have referred to various parliamentary speeches, including those by Rajesh Pilot and Devendra Nath Munshi, to emphasise that entrusting d i s q u a l i f i c a t i o n proceedings to the speaker were aimed at avoiding delays that may occur before courts," it said. The judgement asked the Speaker not to allow the MLAs to prolong the d i s q u a l i f i c a t i o n proceedings. It also asked the speaker to draw adverse inferences if the MLAs protracted proceedings. The verdict, however, rejected the submissions that the apex court itself should decide the

disqualification petitions, referring to some earlier judgements. It also noted that the Speaker did not even issue notice on the disqualification petitions for nearly seven months. "The question therefore we ask ourselves is whether the Speaker has acted in an expeditious manner. Expeditiousness was one of the reasons why Parliament has entrusted the important task of adjudicating disqualification petitions to the Speaker/Chairman. "Non-issuance of notice for a period of seven months and issuing notice only after either the proceedings were filed before this Court or after this Court has heard the matter for the first time can be, by any stretch of imagination, not envisaged as acting in an expeditious manner," it said. BRS working president K T Rama Rao on Thursday welcomed the Supreme Court's directive to the Telangana Assembly Speaker. In a post on 'X', Rao "hoped" that Congress leader Rahul Gandhi, who in his 'Panch Nyay' (promise announced before

2024 Lok Sabha elections) advocated for stronger anti-defection laws and automatic cancellation upon defection, will welcome the Supreme Court's decision. "IDARE YOU to stand by your own preachings, Mr Gandhi. And I hope you and your party doesn't use the honourable Speaker's position to make a mockery of the Indian Constitution, any further," he said. BRS MLA K P Vivekananda told reporters that Chief Minister A Revanth Reddy, without waiting for the Speaker's decision in three months, should make the 10 MLAs resign from their posts and seek a fresh mandate. The ruling Congress, however, hit back at the BRS, recalling that the K Chandrasekhar Rao-led party had encouraged the defection of TDP and Congress MLAs to its side when it was in power from 2014 to 2023. Congress MLC Addanki Dayakar said the whole of TDP's Legislature Party and not just individual MLAs merged with the BRS (then TRS). (PTI)

NARAYANPUR, JULY 31 /-- / A victim of an alleged human trafficking and forceful conversion, in which two nuns have been arrested in Chhattisgarh, has alleged she was coerced and assaulted by Bajrang Dal activists to give a false statement, a charge denied by the right wing outfit. The police also did not record her statement properly, 21-year-old Kamleshwari Pradhan claimed, adding her family has been following Christianity for the last four-five years. The tribal woman, whose parents are farmers, also claimed the two nuns and another person arrested in the case were innocent and said they should be released from jail. However, Bajrang Dal Durg unit convener Ravi Nigam denied all the allegations. "We have neither threatened nor beaten anyone. There are CCTV cameras installed at the railway station, the truth will come out through them," Pradhan said. Nuns Preethi Mary and Vandana Francis, both from Kerala, along with Sukhman Mandavi were arrested by the Government Railway Police (GRP) at Durg railway station in the state on July 25 following a complaint by a local Bajrang Dal functionary, who accused them of forcibly converting three women from the tribal-dominated Narayanpur district and trafficking them. Talking to news agency PTI at her village Kukrajhor in Abujhmad area of Narayanpur, Pradhan claimed she was not being trafficked as she was going along with them at her own will and with her parents' consent. "I was going to Agra with the nuns with the consent of my parents. From there, we were about to go to Bhopal where we were to be given work at a Christian hospital. We were promised Rs 10,000 salary per month along with food, clothes and accommodation," she said. Pradhan recounted that she, Mandavi and two other women from Orchha area of the district reached Durg station early morning on July

25. "The nuns, whom I had never met before, arrived a few hours later there. Meanwhile, we were confronted by a person. Later, other persons from Bajrang Dal joined him. They started threatening, abusing and assaulting us," she said. "The railway police then arrived and we were taken to the (GRP) police station where a woman, Jyoti Sharma, who identified herself as right-wing activist, slapped me and threatened me to change my statement. She told me to say I was taken by force. She said if I didn't, my brother would be jailed and beaten up," Pradhan alleged. She also claimed the police did not take her "actual statement" and were "writing things which she never said." "When I tried to speak, they told me to be quiet and asked if I wanted to go home," she said. Pradhan, who has studied up to class 10, said she was working as a daily wage labourer and used to cycle around 10 km daily to reach the Narayanpur district headquarters to earn Rs 250 per day. "Sukhman Mandavi, who told me about the job, is like a brother to me. We met through the church. Earlier, several women from the area had also gone to work in hospitals. Even a sister of Sukhman had worked outside in a Christian hospital and she later returned," she said. Rejecting the allegations of conversion, she said: "My family has been following Christianity since the last four-five years. My mother used to remain ill. We took them to 'changai' sabha (healing meeting), since then she started recovering, after which we started following the faith." Pradhan claimed the two Catholic nuns and Mandavi were innocent and appealed to the state government to release them. The arrest of the two Kerala-based nuns in the BJP-ruled Chhattisgarh has triggered a political row, with the Congress and the CPIM strongly criticising the move. Chhattisgarh Chief Minister Vishnu Deo Sai, however, accused the Opposition of "politicising the matter". (PTI)

Gujarat: 5 gates of Sardar Sarovar Dam opened as inflow rises; storage

touches 131 metres

EKTA NAGAR (GUJARAT), JULY 31 /-- / Five out of the total 30 gates of the Sardar Sarovar Dam at Ekta Nagar in Gujarat have been opened to maintain the level of water after a huge inflow from the upstream region, officials said. This is for the first time that the gates of the Sardar Sarovar Dam were opened in this monsoon season. In an official statement, the Sardar Sarovar Narmada Nigam Ltd (SSNNL) said five out of the total 30 gates of the dam were opened up to a height of two meters at 11 am on Thursday after the dam's water level increased by 2.71 centimetres in 24 hours. The inflow of water is mainly due to the rainfall in the upstream catchment area in the Narmada basin and the release of water from Omkareshwar dam in neighbouring Madhya Pradesh, it said. At present, the dam, situated near the Statue of Unity in Narmada district, is receiving a 4.22 lakh cusec (cubic feet per second) water while nearly 85,000 cusecs of water is being released into the river by opening five gates, the release said. Uttarakhand tourism dept to prepare master plan for crowd management at religious places

DEHRADUN, JULY 31 /-- / The Uttarakhand tourism department will prepare a master plan focusing on crowd management at religious places and pilgrimage sites in the state, according to an official order. The step has been taken in view of the recent stampede at the Mansa Devi temple in Haridwar that claimed nine

lives. An order to this effect was issued recently by Chief Minister's principal secretary RK Sudhanshu to the Tourism Secretary on the instructions of Chief Minister Pushkar Singh Dhama following the tragic incident. On July 27, nine devotees were killed and 29 others were injured in the stampede which broke out in a narrow stairway leading to the Mansa Devi temple situated atop a hill in Haridwar. The Chief Minister, who reached Haridwar immediately after the incident to take stock of the situation had asked officials to prepare a detailed master plan for the security of devotees visiting major religious places, crowd control, entry-exit system and other necessary facilities. "A master plan will be made for all the pilgrimage sites for the safety and convenience of the pilgrims. The journey will be made more organized by developing public facilities around the pilgrimage sites," Dhama had

said. The tourism secretary has been asked to initiate steps towards working out the master plan at the earliest. The master plan will especially include pilgrimage sites visited by a large number of pilgrims. Help from the Divisional Commissioners of both Garhwal and Kumaon regions should be taken in preparing the master plan and for its implementation, the order issued by the principal secretary said. Illegal encroachments en route to the pilgrimage sites should be removed on a priority basis, it said. The master plan will include major points like crowd control system, development of carrying capacity, separate entry and exit routes, emergency evacuation arrangements, additional space for waiting, clean drinking water, toilets, first aid, well-organized information and guidance system, parking arrangements and deployment of adequate security forces.
