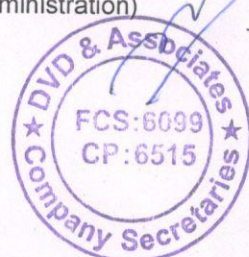

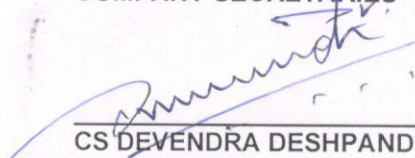
**Result:**
