Re: Intimation regarding postponement and rescheduling of meeting of board of directors ("Board") of Sical Logistics Limited ("Company")

This is further to our intimation dated January 23, 2026 of the meeting of the Board of the Company, wherein the offer and issuance of equity shares of face value of ₹10 each of the Company ("Rights Equity Shares"), as decided by the Board, by way of a rights issue to the eligible equity shareholders, for an amount not exceeding Rs. 11,000 Lakhs ("Rights Issue"), in accordance with the Companies Act, 2013, as amended and the rules made thereunder, the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended and other applicable laws, was approved and in furtherance to our prior intimation of meeting of the Board dated January 23, 2026 and January 30, 2026 addressed to BSE Limited and National Stock Exchange of India Limited (collectively 'the Stock Exchanges') , inter alia, to consider, discuss and decide various matters in connection with the Rights Issue, including the specific terms of the Rights Issue, such as the determination of the Rights Issue price and related payment mechanism, rights entitlement ratio, the record date, timing of the Rights Issue and other terms and conditions.

In view of the applications for in-principle approvals for the Rights Issue, submitted by the Company to the Stock Exchanges on Tuesday, January 27, 2026, the Company had re-scheduled its meeting of its Board on Tuesday, February 3, 2026, to consider, discuss and decide various matters in connection with the Rights Issue, in anticipation of receiving the in-principle approval from the Stock Exchanges on or before Tuesday, February 3, 2026. Since the Stock Exchanges are still considering the Draft Letter of Offer the Board has decided to reschedule/postpone today's meeting i.e. Tuesday, February 3, 2026 till receipt of the in-principle approval from the Stock Exchanges.
