Sub: Intimation regarding payment made to the party by virtue of order passed by Hon'ble Supreme Court of India

Ref: Regulation 30 of SEBI LODRR read with Schedule III Part A – Disclosure of events or information

HOCL had a long-term dispute with the landlord M/s. Harchandrai & Sons from whom the company had taken on lease the office premises in Mumbai. This dispute has been in the domain of various courts for more than two-and-a-half decades. The Hon'ble Supreme Court of India vide order dated 06.05.2025 received in our office on 28.07.2025 disposed the case by directing HOCL to pay the disputed rent along with reduced interest rate of 6% (simple in nature per annum) to the landlord. In this matter the company filed a Special Leave Petition to the Supreme Court and obtained 6 months extension of the time period to remit the payment to the party. Today, company has remitted the payment in the Court of Small Causes at Mumbai. Accordingly, this litigation stands closed. The relevant details as per Regulation 30 of SEBI LODRR read with Schedule III, Part A is given below:
