Dear Sir / Madam,

In continuation of the Company's disclosure dated 14<sup>th</sup> October 2024 (SPIL/CS/SE/2024-25/37), regarding approval of the Board to acquire 2,09,100 equity shares of Rs.10/- each of Ishwari Healthcare Private Limited (CIN 85100MH2011PTC212867), (referred to as 'Ishwari Healthcare'), pursuant to Regulation 30 of SEBI (Listing Obligation And Disclosure Requirements) Regulations, 2015, this is to inform you that the Company has acquired the said 2,09,100 equity shares of Rs.10/- each of Ishwari Healthcare (51.00% of paid up equity share capital) from Mr. Shatrughan Nenwani at a revised consideration of Rs.1,50,00,000/- (Rupees One Crore And Fifty Lakhs only) i.e. at the rate of Rs.71.73/-per share.

As per the Company's previous announcement dated 14<sup>th</sup> October 2024, the consideration was fixed at Rs.2,60,00,000/- (Rupes Two Crores and Sixty Lakhs only); however, multiple rounds of negotiations, the consideration was revised at Rs.1,50,00,000/- (Rupees One Crore And Fifty Lakhs only).

Consequent to the aforesaid acquisition, Ishwari Healthcare has become a subsidiary of the Company with effect from 1<sup>st</sup> April, 2025.
