# Chennai woman undergoes complex jaw surgery

Chennai, Jun 3: A 23-year-old medical student suffering from a severe jaw disorder has regained full jaw movement after undergoing a complex total joint replacement surgery at Kauvery Hospital, Alwarpet.

Diagnosed with temporomandibular joint (TMJ) ankylosis at age five, the condition had fused her jaw joint, limiting her ability to eat, speak, and perform daily activities. Despite undergoing two to three earlier surgeries, the problem persisted, leading to facial asymmetry

and misaligned teeth. Seeking a permanent solution, she approached the Department of Oral and Maxillofacial Surgery at Kauvery Hospital. Led by senior surgeon Dr. Manikandhan, the team performed a customized TMJ total joint replacement using a high-grade titanium prosthesis coated with ceramic nitric oxide to reduce wear and improve function.

The eight-hour surgery also involved repositioning the upper jaw to correct bite alignment and facial symmetry. Advanced CT imaging

and 3D modeling were used to tailor the procedure precisely to her anatomy.

"This specialized surgery restores both joint movement and facial structure," said Dr. Manikandhan. "We're the first in Chennai to use this advanced implant."

Dr. Aravindan Selvaraj, Co-founder and Executive Director of Kauvery Hospital, praised the team's effort, calling the procedure a blend of modern surgical innovation and personalized care that changed the young woman's life.
