In a first, central govt directs offices of ministers: Clear all files pending for over two months

HARIKISHAN SHARMA NEW DELHI, JULY 2

PUSHING TO cut delays in decision-making at the top, the Cabinet Secretariat has for the first time sent letters directly to the offices of Central ministers where files have been pending for more than two months, asking them to clear the backlog at the earliest, The Indian Express has

The letters were sent in the second half of June and mention the number of pending files. Until now, the pendency of files used to be reviewed at the level of joint secretary, additional secretary and secretary, and not by the offices of ministers.

The Cabinet Secretariat is learnt to have been monitoring pendency at each level using the Government's E-Office digital

workplace, which has around 7,000-8,000 e-files in circulation daily, of which about 2,000 go to the offices of ministers. A majority of these files pertain to interministerial subjects, such as national policies and schemes.

It learnt that the Cabinet Secretariat has flagged files pending at ministers' offices for 61-90 days, 91-120 days and over 180 days. At one minister's office, several dozen files were found pending, it is learnt. At another minister's office, files related to the release of funds for a state were found pending for more than six

The move to flag pendency at this level is the latest measure taken by the NDA Government to cut bureaucratic delays.

The Government has earlier launched PRAGATI (Pro-Active Governance and Timely Implementation) to monitor implementation of infrastructure projects. It has been described as a three-tier system that includes officials at the Prime Minister's Office, Central Government Secretaries and Chief Secretaries of states.

The Prime Minister chairs a monthly meeting of PRAGATI where he interacts with Central Secretaries and Chief Secretaries through video-conferencing. This platform has helped accelerate over 340 "critical projects" since its inception in March 2015, sources said.

In October 2021, the Government launched the PM GatiShakti platform to facilitate planning and decision-making on infrastructure projects. Another platform, e-SamikSha, is also being used as a real-time monitoring system for follow-ups on announcements and decisions pertaining to Central ministries.

MNS workers assault man for not speaking Marathi, FIR filed

MUMBAI, JULY 2

ADAY after the video of a 48-yearold sweet shopowner in Mumbai's Mira Road being assaulted allegedly by a group of men affiliated to the MNS for not speaking Marathi went viral, senior MNS leaders on Wednesday defended the action of the party workers. The police on Tuesday registered an FIR against seven persons on a complaint by the shopowner and issued notices to three of them.

Meanwhile, Minister of State for Home Yogesh Kadam, while condemning the incident and urging people not to take the law into their hands, said, "The government will not tolerate disrespect towards Marathi language."

According to the FIR registered at the Kashimira police station in Mira-Bhayander on Tuesday, the incident occurred around 10:35 pm on June 29 at 'Jodhpur Sweets and Namkeen', a shop located in Mira Road (East). The shopowner, Baboolal Khimaji Choudhary, a resident of

Bhayander (East), stated in the FIR that seven unidentified men, aged between 20 and 30, entered his shop. Five of them were wearing scarves bearing the MNS name and symbol, he said.

In his complaint, Choudhary stated, "They asked me my identity. When I told them I was the owner, they claimed a proposal had been passed in the Maharashtra Assembly requiring all businesses to hire Marathispeaking staff and operate in Marathi. When I asked them when such a proposal was passed, they said 'two days ago' and then asked me which official language is spoken in Maharashtra, When I responded that all languages are

aggressive and started assaulting

Originally from Rajasthan, Choudhary has been running the shop on rent for over a year and employs eight workers, "My business runs from 7 am to 11 pm daily, and it supports my entire family. What happened that night was terrifying," he added.

The police have identified the three persons seen hitting the shopowner in the viral video as Karan Kandangire (31), a resident of Mira Bhayander and MNS's deputy city chief; Pramod Nilekat, party's Vaahtuk Sena district organiser; and Akshay Dalvi, an MNS worker from Dahisar in Mumbai

Police have registered a case under relevant sections of the BNS pertaining to assault, criminal intimidation, intentional insult, and promoting enmity based on language. "We have registered an FIR and issued notices to the three accused," said Rajendra Kamble, senior police inspector of Kashimira police station. The accused remain at large.

to Marathi. File FIRs or charge us with false sections, we are not afraid.

MNS leaders defended the action of the party workers. "Our people were celebrating after the GR on the three-language policy was withdrawn by the government, when some of our workers went to the shop to purchase water bottles. The shopowner insulted Marathi that led to an argument," MNS leader and party spokesperson Sandip Deshpande said. Sandeep Rane, Mira Bhayander city chief of MNS, said, "Our party workers were celebrating the withdrawal of the GR. The shopkeeper started asking why were we celebrating and insulted Marathi language and people."

Kadam condemned the incident. "For the past several months, there has been a controversy around Hindi and Marathi. Some are using this issue ahead of the municipal elections. I urge everyone not to take the law into their hands. Marathi should be respected, but any grievance should be reported to the police," Kadam said

HC orders Shami to pay ₹4 lakh monthly alimony to estranged wife, daughter

THE CALCUTTA HC has ordered cricketer Mohammed Shami to pay an interim amount of ₹4 lakh per month as alimony to his estranged wife Hasin Jahan and their daughter, amid the ongoing legal case with his spouse.

Justice Dr Ajoy Kumar Mukherjee directed that ₹1,50,000 be paid to his wife and ₹2,50,000 to the daughter until the disposal of a case of alleged domestic violence against him. The court said the amounts would "be fair and reasonable" to ensure financial stability for both the wife and daughter "until the disposal of the main application". "Such amount is to be paid by the opposite party/husband from the date of filing of the application under section 23 of the Protection of Women from Domestic Violence Act," the court added.

Jahan said: "We are relieved. As a father, if he (Shami) gave the alimony before, it would have benefitted the child. Now, I can send her to a good school."

India's 1st Ph-3 dengue vaccine trial touches 50% enrolment mark

INDIA HAS reached the 50% enrolment mark in its first phase-3 clinical trial for the indigenous tetravalent dengue vaccine, DengiAll, with over 7,000 participants randomised across 20 trial sites. Initial results show no safety concerns for the one-shot vaccine for the mos-

quito-borne viral disease. Developed by Panacea Biotec Limited under a licensing agreement with the National Institutes of Health (NIH), the primary

United States federal agency for biomedical research, DengiAll targets all four dengue virus subtypes and has shown promising results in earlier clinical trials.

The study, coordinated by the ICMR, seeks to recruit 10,355 volunteers aged 18-60, with followups extending to two years postvaccination. Participants will receive either the vaccine or a placebo to test its efficacy. The trial has been approved by the DCGI and aims to conclude enrolment by October. DengiAll has a weakened form of all four dengue virus subtypes and the same virus com-

position as the vaccine developed

by NIH, except for the inactive ingredients. The NIH also evaluated the vaccine in the US and the results were found to be promising in early-stage clinical studies. A Phase I/II clinical trial conducted in India among humans revealed a balanced and robust immune response across all four dengue virus types. The vaccine was also found to be safe and well-tolerated in the trial. The ICMR-National Institute of Translational Virology (NITVAR) and AIDS Research (formerly ICMR-NARI) is responsible for overall trial coordination and has $been identified \, as \, a \, designated \, site$ for participant enrollment.

THE UNION Health Ministry on Wednesday said extensive studies by several agencies have "conclusively established no linkages" between Covid-19 vaccines and sudden deaths. It came a day after Karnataka Chief Minister Siddaramaiah linked a "series of deaths" due to heart attacks in the state's Hassan district to "hasty approval and distribution" of Covid

Citing studies conducted by the Indian Council of Medical Research (ICMR) and the National Centre for Disease Control (NCDC), the Ministry said: "The matter of sudden unexplained deaths has been investigated through several agencies in the country. These studies have conclusively established that there is no direct link between Covid 19 vaccination and the reports of

sudden deaths in the country." The Ministry also said preliminary findings of a study currently being conducted by AIIMS, Delhi indicate that "heart attacks continue to be the leading cause of sudden death" among young adults. "In majority of the unexplained death cases, genetic mutations have been identified as a possible cause of these deaths," the statement said.

On Tuesday, Siddaramaiah, in a post on X, said more than 20 people had died of heart attacks in Hassan in the past one month alone and "it cannot be denied that the hasty approval and distribution of the Covid vaccine to the public could also be a reason... as several studies worldwide have recently indicated that Covid vaccines could be a cause for the increasing number of heart attacks." He said the state has formed a panel of experts "to identify the exact cause of these series of

deaths and to find solutions". There are several reasons why the 20 deaths in Hassan are not a red flag. First, the number: there were 18,568 deaths registered in Hassan district in 2023, translating to nearly 51 deaths a day, according to Karnataka's Vital Statistics Report 2023.

Second, heart attack is one of the most common causes of death in India, Cardiovascular diseases, including heart attacks, account for more than a quarter of all deaths in India, according to data from Global Burden of Diseases. Third, a study by the ICMR on the link between sudden deaths and Covid-19 vaccination found that immunisation did not increase
