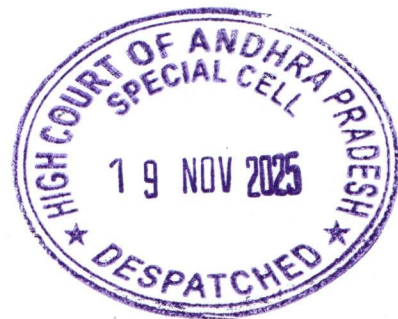

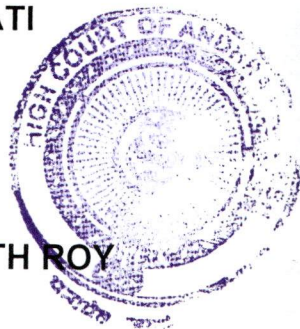

Petition under Section 151 CPC is filed praying that in the circumstances stated in the grounds filed in support of the petition, the High Court may be pleased to stay of all further proceedings in O.A.No.914 of 2024 on the file of the Court of the Debt Recovery Tribunal, Visakhapatnam, Pending disposal of CRP No. 2795 of 2025, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case).

**ORDER:**

The petitioner is the Indian Bank. It has filed O.A.No.914 of 2024 on the file of the Debt Recovery Tribunal, Visakhapatnam for recovery of a sum of Rs.141,94,49,603/- from the respondents. During the course of the trial, the petitioner has examined its Officer, who is the Chief Manager of the Bank as A.W.1. After filing of his chief-examination affidavit, he was not produced for cross-examination by the respondents. It is stated as he was subsequently transferred to another branch in Gujarat, he could not be produced for cross-examination. Therefore, the Debt Recovery Tribunal has closed the evidence of the

petitioner and posted the matter for adducing the evidence of respondents. The Debt Recovery Tribunal by the impugned order has expunged the evidence of A.W.1.

Challenging the validity of the said order, the present Civil Revision Petition is filed.

It is contended that if no stay of further proceedings is granted, as the matter is posted for adducing the evidence of the respondents, irreparable loss will be caused to the Bank as they could not be in a position to establish their case without adducing the evidence on their behalf.

Therefore, in the said facts and circumstances, there shall be stay of all further proceedings in O.A.No.914 of 2024 on the file of the Debt Recovery Tribunal, Visakhapatnam, till the next date of hearing. /)

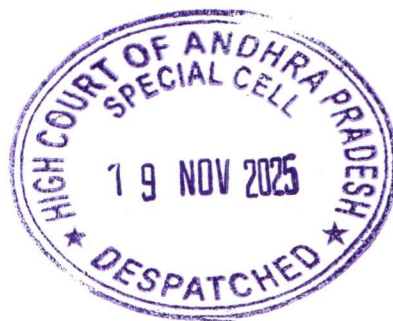
