In compliance of Regulation 30 of SEBI (LODR), 2015 and in terms of sub-para 20 of para A of Part A of Schedule III, this is to inform you that G. G. Automotive Gears Limited has received email for Fines as per SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 (Chapter-VII(A)-Penal Actions for Non-Compliance) from BSE and Email/Letter dated 28th November, 2025 from BSE regarding Non-Compliance with the provisions of Regulation 17(1) of SEBI (LODR) Regulations, 2015 respectively i.e. Noncompliance with the requirements pertaining to the Composition of the Board including failure to appoint Independent Director. In this regard both BSE has imposed fines on G. G. Automotive Gears Limited amounting to Rs. 3,06,800/- (Three Lakh Six Thousand Eight Hundred Only) respectively.
