		made loss while doing the contra trade, and this was a first violation without in possession of any UPSI and accordingly in terms of the charter of the Disciplinary Committee, upon perusal of the documents, the Committee levied a Penalty of Rs. 5,000/-. Further, a Warning letter has also been issued.
6.	Reasons recorded in writing for taking action stated above	This being the first incident of the insider, the Disciplinary Committee imposed a penalty of Rs. 5,000/- for the violation, in terms of the charter of the Disciplinary Committee.
