Q3 FY26 Consolidated revenue was Rs 673.4 Crores, a 9.6% YoY increase

Plywood Business* Volume grew by 12.5% Y-o-Y in Q3 FY26 with a Core EBITDA margin of 8.4%

MDF Business Volume grew by 14.5% Y-o-Y in Q3 FY26 with a Core EBITDA margin of 10.1%

Kolkata, Feb 4th, 2026: Greenply Industries Limited, India's leading manufacturer of Plywood, MDF and allied products has announced its financial results for the quarter ended December 31, 2025. The key financial highlights are as follows:

Plywood Business * – Q3 FY26

- Revenue from Plywood & allied products was Rs 521.7 crores, a 8.9% increase on y-o-y basis.
- Realization per SQM was Rs 244, a 4.9% decrease on y-o-y basis due to change in product mix
- Core EBITDA was Rs 43.6 crores, with a core EBITDA margin of 8.4% as against 8.2% in the previous quarter a growth of 20 Bps.
- Net profit was Rs 21.7 crores.

MDF Business – Q3 FY26

- Revenue from MDF business was Rs 152.0 crores, an 11.7% increase on y-o-y basis.
- Realization per CBM was Rs 31,385.
- Core EBITDA without forex loss was Rs 15.4 crores, with a core EBITDA margin of 10.1% as against 8.3% in the previous quarter a growth of 180 Bps.
- Net profit was Rs 0.4 crores.

Greenply Samet JV – Q3 FY26

- Total revenue was Rs 13.38 crores (100%)
- Share of PAT loss was Rs 7.7 Crs (50%)

Consolidated – Q3 FY26

- Revenue was Rs 673.4 crores, a 9.6% increase on y-o-y basis.
- Core EBITDA was Rs 58.9 crores, with an EBITDA margin of 8.7% as against 8.2% in the previous quarter a growth of 50 Bps.
- PAT was Rs 14.3 crore.

Plywood Business * – 9M FY26

- Revenue from Plywood & allied products was Rs 1,517.2 crores, a 5.0% increase on y-o-y basis.
- Realization per SQM was Rs 247.
- Core EBITDA was Rs 124.2 crores, with an EBITDA margin of 8.2%.
- Net profit was Rs 68.2 crores.

MDF Business – 9M FY26

- Revenue from MDF business was Rs 446.2 crores, 13.1% increase on y-o-y basis.
- Realization per CBM was Rs 31,434.
- Core EBITDA without forex loss was Rs 53.1 crores with an EBITDA margin of 11.9%.
- Net profit was Rs 4.4 crores.

Greenply Samet JV – 9M FY26

- Total revenue was Rs 31.28 crores (100%)
- Share of PAT loss was Rs 19.0 Crs (50%)

Consolidated – 9M FY26

- Revenue was Rs 1,962.8 crores, a 6.7% increase on y-o-y basis.
- Core EBITDA was Rs 177.3 crores, with an EBITDA margin of 9.0%
- PAT was Rs 58.8 crore.

Commenting on the performance for Q3 & 9M FY26, Mr. Manoj Tulsian, JMD & CEO, Greenply Industries Ltd. said

"We are on track with our volume growth guidance. This is due to the strategic focus on our mid-bailey brand Ecotec achieving an overall 12.5% y-o-y volume growth. We are confident that this will continue with further improvement in margins.

In our MDF business, after the successful expansion we experienced some initial challenges in the first 2 months of Q3 FY26, which impacted sales growth and resulted in margins of 10.1% for the quarter. We believe the revenue will be substantially better in coming quarters with margins reaching 16%.

With the announcement of the new MDF facility in Vadodara we are entering into a new capex cycle and becoming ready for the future growth.

Our JV Greenply Samet revenue is increasing well witnessing a q-o-q growth of 18%, achieving revenues of Rs.13.3 crore for this quarter."
