Similar reports have been published in various mainstream media outlets. To prevent any misinformation and ensure full transparency, the Company would like to place on record the following clarifications:

- BFL had entered into a Tripartite Memorandum of Understanding (‘MoU’) on September 26, 2025 at Pune along with BEM Limited and Data Patterns (India) Limited, to collaborate for the Advanced Medium Combat Aircraft (‘AMCA’) programme and to participate in the Expression of Interest (‘Eoi’) floated by Aeronautical Development Agency (‘ADA’). An intimation in this regard was released to the Exchanges on September 26, 2025.
- With respect to the above-mentioned article(s), while BFL’s participation in this bid is factually correct information, we are not aware of any other information and nothing is communicated to us by ADA and / or Ministry of Defence.
