Sri Susanta Kumar Dhal</p> <p>Court: Hon'ble High Court of Telangana at Hyderabad.</p> <p>Brief facts of the case: The Company had entered into a production agreement dated 16th December 2024 with Smt. Sakuntala Dhal for production of Hybrid Paddy (JKRH517) and gave an advance of Rs. 67.89 Lakh.</p> <p>Pursuant to the said Agreement, the party has supplied seeds only worth of Rs. 6.66 Lakh.</p> <p>Accordingly, the Company demanded refund of balance advance amount of Rs. 61.23 Lakh. However, the party refused to refund.</p> <p>After multiple correspondence, the Company issued demand legal Notice dated 21st November 2025 for refund of balance advance of Rs. 61.23 Lakh and for invoking Arbitration clause for dispute resolution.</p> <p>Inspite of receipt of the Company's Notice, the Party neither replied nor refund the amount.</p> <p>On 3rd February 2026, the Company has filed an application before Hon'ble High Court of Telangana at Hyderabad under Section 11(5) & 11(6) of the Arbitration & Conciliation Act, 1996 for appointment of Arbitrator in the matter for dispute resolution.</p>
