In continuation to our communication dated December 20, 2025 regarding the Stay Order, on recovery of penalty, passed by Hon’ble Securities Appellate Tribunal (“SAT”), we wish to inform that the Company has received an order dated 03rd February, 2026 passed by the Hon’ble Securities Appellate Tribunal (SAT), Mumbai, in Miscellaneous Application No. 108 of 2026 in Appeal No. 549 of 2025, filed by the Company and the promoters of the Company.

The Company had moved the aforesaid Miscellaneous Application before the Hon’ble SAT seeking specific interim reliefs, inter alia, to enable the Company and the promoters to raise funds for meeting working capital requirements and for timely execution and completion of existing, time-bound work orders and the Hon’ble Tribunal has, after considering the submissions, partly allowed the application.

The appeal against SEBI’s order dated 28th November, 2025 continues to remain pending for final adjudication.
