Summary of amendments in Clause III(A) MOA of the Company:

S. No.	Changes
1.	To insert the following clause 3 in the clause III(A) of the Memorandum of Association of Company
	1. "To carry on the business as a manufacturers, traders, importers, exporters, dealers and suppliers of Organic Chemicals of all kinds including pharmaceuticals bulk drugs, formulation, whether allopathic, ayurvedic or otherwise."
	2. To carry on the business as a manufacturers, traders, importers, exporters, dealers and suppliers of creams, scents, toilet goods and cosmetic and medicinal preparations used for beauty aid, orthopaedic and surgical appliances.
	3. To carry on the business as a manufacturers, traders, importers, exporters, dealers, agents, stockiest, distributors, suppliers, refiners, processors of all kind and forms of organic/inorganic chemicals, heavy chemicals, including insecticides, all types of fertilizers, pesticides, weedicides, fungicides, fumiganants, rodanticides, graphite, carbon, petrochemicals, acids, alkalies, salts, cardials and any other article or things of a character similar or analogous to the forgoing or any of them connected therewith.
