This is with reference to the disclosure filed by the Company on February 05th, 2025 regarding demand order received from CGST authorities, Noida wherein it was stated that the GST department has confirmed demand amounting to INR 80.22 Lakhs on account of reversal of the various cesses which were transitioned into the GST regime in accordance with the law and was appropriated against the amount already reversed by the Company under protest.

However, Form DRC-07, being a summary order, inadvertently confirmed the demand once again for an amount of INR 80.22 Lakhs without taking into account the appropriation made in the main order.

The Company subsequently filed an application for rectification of DRC-07 order u/s 161 of CGST Act, 2017 wherein the demand, which was inadvertently uploaded on GSTN portal (though appropriated in main order)Further, the Company received a rectification order in DRC-08 where the rectification has been accepted and demand has now been rectified and appropriated on GSTN portal as well.

As per the requirement of Regulation 30 of the Listing Regulations, read with SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, we wish to disclose the details of rectification order received by the Company as per Annexure-A.
