SUBJECT: Press Release:- Action by the Excise Department, Madhya Pradesh - Disclosure / Intimation under Regulation 30 of SEBI (LODR) Regulations 2015

Som Distilleries and Breweries Limited wishes to address media reports concerning regulatory action taken by the Excise Department of Madhya Pradesh and to reassure it's all stakeholders.

The company clarifies that an arbitrary action has been taken by Excise Commissioner, Madhya Pradesh on the basis of a case of year 2012 in which Som Distilleries & Breweries has not been a party. The case does not pertain to the company and the judgment in question relates to certain individuals who were not even employees of the Company at the time of judgement. The order was passed by the Sessions Court, Betma, Madhya Pradesh and the matter is currently under appeal before the Hon'ble High Court of Madhya Pradesh at Indore, which has stayed both the judgment, and the sentences awarded to the said individuals.

The company acknowledges the suspension of manufacturing unit license by the Excise Authorities in connection with this old and historical case. The Company is pursuing appropriate legal recourse before the Hon'ble High Court of Madhya Pradesh at Jabalpur, where the matter is presently listed. The Company continues to contest the matter and shall disclose any material outcome in due course.

The Management would like to categorically assure all stakeholders that:

- The case pertains to legacy issues and does not reflect the Company's current governance or control environment.
- The company remains a going concern with strong underlying business fundamentals.
- There is no impact on financial stability, liquidity, or debt servicing ability, and all banking obligations and covenants continue to be met on time.
