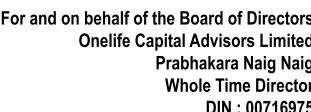

- 2 The above results have been reviewed by the audit committee and thereafter approved by the Board of Directors in their meeting held on 4th February 2026.
- 3 In accordance with Ind-AS-108 "Operating Segments", the company has only one reportable primary business segment i.e. "Chemical Manufacturing". However, the company has secondary geographical segment which is disclosed in the financial statement as per Ind AS-108.

The segment asset and segment capital expenditure attributable to the segment "Outside India" is less than 10% of the respective total assets and total capital expenditure and therefore not disclosed separately.

- 4 The Company post notification of new labour code has evaluated its implication on employee benefits and considered the same while making provision for employee benefits including actuarial based gratuity provisions in the financial results. On account of the change the incremental impact is Rs.1.72 lakhs which is charged to the Profit and Loss Statement.
- 5 As at 31st December, 2025 the company does not have any subsidiary/associate/Joint venture entity (IES).
- 6 The figures for the previous financial period have been regrouped/rearranged wherever necessary.
