Pursuant to Regulation 30 of the Listing Regulations read with Part-B of Schedule III of Listing Regulations and SEBI Master Circular no HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January 30th, 2026, We (SSL) are hereby informing that in compliance of Central Pollution Control Board (CPCB) directions received under Section 5 of the Environment (Protection) Act,1986 **Closure of operations of Unit-Simbhaoli Distillery (Hapur) w.e.f 5th February, 2026.**

As said unit was already in operational mode when the Directions from CPCB received on 2nd February, 2026 via email and Immediately upon completion of the ongoing distillation process i.e finishing the inprocess materials like molasses, fermented wash to produce alcohol which takes around 72 hours, the said unit is shut down on 5th February, 2026. The concerned officials are presently taking all necessary and adequate measures to restore the operations of the said Unit (Simbhaoli Distillery-Hapur) in compliance with the applicable directives and environmental norms.

The exact period of closure of said Unit cannot be ascertained and will remain closed till next directions received from CPCB for revocation.
