Dear Sir,

I, Amit K. Rajkotiya, Practising Company Secretary, (C.P. No. 5162) having office at 1st Floor, Swapnil Swarnadi Apartments, Plot No. 363, M.A.K. Azad Road, Gandhi Nagar, Nagpur-440010, have been appointed as Scrutinizer by the Board of Directors at its Board meeting held on 7th February 2025 of Diffusion Engineers Limited ("the Company") having its registered office at T-5 & 6, MIDC, Hingana, Nagpur, 440016 for the purpose of scrutinizing the Postal Ballot voting conducted by way of remote e-voting process ("e-voting") in a fair and transparent manner on the resolution contained in the postal ballot notice dated 04th March 2025 ("Notice") issued in accordance with General Circular No. 14/2020 dated April 8, 2020, General Circular no. 17/2020 dated April 13, 2020, General Circular no. 22/2020 dated June 15, 2020, General Circular no. 39/2020 dated December 28, 2020, General Circular No. 39/2020 dated December 31, 2020, General Circular no. 10/2021 dated June 23, 2021, General Circular no. 20/2021 dated December 08, 2021, General Circular no. 3/2022 dated May 05, 2022, General Circular No. 11/2022 dated December 28, 2022, General Circular No. 09/2023 dated September 25, 2023 and General Circular No. 09/2024 dated September 19, 2024, issued by the Ministry of Corporate Affairs (MCA), Government of India (hereinafter referred to as "MCA Circulars").

1. The said appointment as Scrutinizer is under the provisions of Section 108 and Section 110 of the Companies Act, 2013 ("the Act") read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended ("the Rules") and as notice dated 04th March 2025 along with explanatory statement under section 102 of the Act were mailed to shareholders whose names appeared on the register of members of the company as on the cut off date i.e 21st February,2025 who were entitled to vote on the resolution and as the Scrutinizer, I have to scrutinize and reviewed the process of e-voting conducted for the postal ballot, using an electronic voting system on the dates referred to in the Notice.

2. Management's Responsibility

The management of the Company is responsible to ensure compliance with the requirements of (i) the Act and the Rules made thereunder; (ii) the MCA Circulars; and (iii) the SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015, ("LODR") relating to e-voting on the resolution contained in the Notice. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.

3. Scrutinizer's Responsibility

My responsibility as a scrutinizer for remote e-voting through postal ballot is restricted to making a Scrutinizer's report of the *votes* cast "in favour" or "against" by the members in respect of the resolution contained in the Notice. My report is based on verification of data and reports generated from the voting system provided by Central Depository Services (India) Limited" ("CDSL") and the Agency authorized under the Rules and engaged by the Company to provide e-voting facility and attendant papers/ documents furnished to me electronically till the time fixed foreclosing of the e-voting process i.e. till 5 p.m. on 03rd April 2025.

4. Cut -off date

The Members of the Company as on the "cut-off" date as set out in the Notice i.e. Friday, February 21st, 2025 were entitled to *vote* on the resolution set out in the Notice and their voting rights were in proportion to their shareholding in the paid-up equity share capital of the Company as on the cut-off date, subject to the provisions of Articles of Association of the Company.

5. Remote e-voting process

- i. The remote e-voting period remained open from Wednesday, March 05, 2025(9.00 a.m. IST) and ended on Thursday, April 03, 2025 (5.00 p.m. IST).
- ii. The votes cast during the remote e-voting were unblocked on Thursday, April 03, 2025 after the conclusion of e-voting period for Postal Ballot and was witnessed by two witnesses, Ms. Bhagyashri Neware and Mr. Ajay Rana, who are not in the employment of the Company and / or Central Depository Services (India) Limited" ("CDSL").
