During the course of the inspection, the Officer collected samples of various food products stored at the premises. Upon analysis, it was found that one of the sampled products "Boondi (First Crop Brand)" was not in the confirmation of the relevant provision of the Laws.</p> <p>Subsequently, the Food Safety Officer filed a complaint before the Additional District Magistrate, Bijnor, alleging violation of the provisions of the Food Safety and Standards Act, 2006. Pursuant thereto, a penalty of Rs. 1,50,000/- (Rupees One Lakh Fifty Thousand Only) has been imposed upon the Subsidiary (Airplaza Retail Holdings Private Limited) and Rs. 1,25,000/- (Rupees One Lakh Twenty Five Thousand Only) has been imposed upon the Company.</p>
