New Delhi: The Comptroller and Auditor General (CAG) of India has flagged a provision in the NHAI's tender for road builders

through post-tender amendments to agreements signed with the National Highways Authority of India (NHAI). The auditor said the NHAI granted

deferment of premium amounting to ₹9,296.25 crore for eight years to 14 years for 20 projects till October 2019.

This deferment was on the basis of a scheme formulated by the NHAI after it assessed a revenue loss of ₹98.115 crore to the exchequer if the projects were terminated.

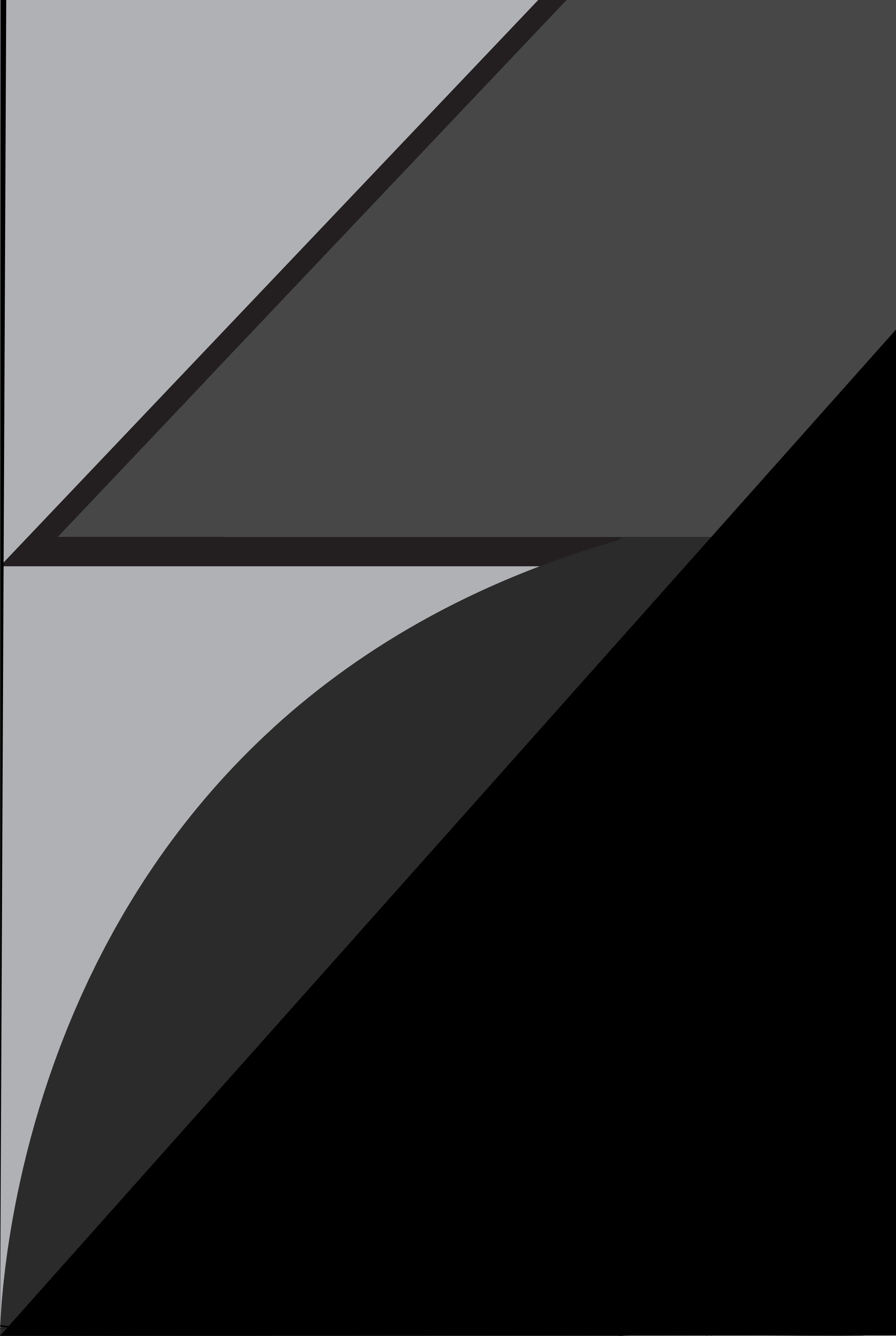
