# **Pro-Taliban cleric among** 18 killed in Af mosque blast



n explosion tore through a crowded mosque in western Afghanistan on Friday, killing at least 18 people, including a prominent cleric close to the Taliban, Taliban officials and a local medic said. At least 21 people were hurt.

The explosion in the city of Herat left the courtyard of the Guzargah Mosque littered with bodies, the ground stained with blood, video from the scene showed. Men shouted, "God is great," in shock and

The bomb went off during Friday noon prayers, when mosques are full of worshippers.

Among the dead was Mujib-ul Rahman Ansari, a prominent cleric who was known across Afghanistan for his criticism of the country's Western-backed governments over the past two decades. Ansari was seen as close to the Taliban, who seized control over Afghanistan a year ago as foreign forces withdrew.

His death was confirmed by the chief Taliban spokesman, Zabihullah Mujahid. Just before the bombing, Ansari had been meeting in another part of the city with the Taliban government's deputy prime minister, Mullah Abdul Ghani Baradar, who was on a visit to Herat. He had rushed from the meeting to the mosque to get to the noon prayers, an aide to Baradar said in a tweet mourning the cleric.

Ambulances transported 18 bodies and 21 people wounded from the blast to hospitals in Herat, said Mohammad Daud Mohammadi, an official at the Herat ambulance center,

There was no immediate claim of responsibility for Friday's blast.

Last month, a bombing at a mosque in the capital Kabul targeted and killed a pro-Taliban cleric in an attack claimed by the Islamic State group. ISIS has waged a bloody campaign of attacks on Taliban targets and minority groups, particularly Shiites whom the extremist Sunni IS considers heretics. It has frequently hit mosques with suicide attacks during Friday prayers.

Herat's Guzargah Mosque, where Ansari has long been the preacher, draws followers of Sunni Islam, the dominant stream in Afghanistan that is also followed by the Taliban.

Ansari was for years a thorn in the side of Afghanistan's pro-Western government. In his sermons at the Guzargah, he urged his many supporters to carry out protests against the governments and preached against women's rights.

## Voting closes in UK Prime Minister race between Sunak, Liz

The race to replace Boris
Johnson as the Conservative Party leader and the British Prime Minister closed on Friday evening, the deadline for Tory members to register their choice between Indian-origin former Chancellor Rishi Sunak or Foreign Secretary Liz Truss.

Sunak, 42, and Truss, 47, have gone head-to-head in a dozen hustings up and down the UK over the past month to win over the votes of an estimated 160,000 Tory electorate. With the ballots now closed, the result will be declared at 12.30pm local time on Monday by returning officer Sir Graham Brady, the Conservative Campaign Headquarters (CCHQ) said.

"This hustings programme has shown the strength of our party across the UK, with sold



out events filling Wembley Arena to Perth Concert Hall," said Conservative Party Stephenson.

"I'd like to thank Rishi Sunak and Liz Truss for participating in what, at times, must have been a gruelling schedule in good spirits and giving our members the opportunity to question them up front and personal, answering

over 600 questions and putting themselves under the spot-light... Whatever the result come Monday, I know our party is ready to unite around a new Leader and tackle the challenges we face as a country ahead," he said.

The CCHQ said 19,859 attended the 12 hustings events and a total of 2.2 million people viewed them across online platforms. While the British Indian former minister pegged his campaign on getting a grip on soaring inflation as an immediate priority, the foreign minister has pledged tax cuts from day one in office.

Overall, it is how they plan to tackle the cost-of-living crisis faced by the British public that has dominated the debates even as the duo addressed their final hustings in London on Wednesday night, where they reiterated many of their

An Israeli attack targeting a Syrian airport tore a hole in the runway and also damaged a nearby piece of tarmac and structure on the military side of the airfield, satellite photos analysed on Friday by The Associated Press showed.

The attack on Wednesday night on Aleppo International Airport comes as an Israeli strike only months earlier took out the runway at the country's main airport in the capital, Damascus, over Iranian weapons transfers to the country. The satellite photos taken on Ťhursday by Planet Labs PBC showed vehicles gathered around the site of one of the strikes at the airport, near the western edge of its sole runway.

Trump, his die-hard followers trying to undermine American democracy: Biden

President Joe Biden has warned Americans that his predecessor Donald Trump and his die-hard followers are trying to "undermine" democracy and asked them to confront the "extremists" who fan the flames of political violence in pursuit of Delivering his sharpest rebuke yet of

Republicans in a prime-time speech from the iconic Independence Hall in Philadelphia, where the US Declaration of Independence was signed nearly 250 years ago, Biden warned that the supporters of Trump's "Make America Great Again" MAGA) agend democracy.

"As I stand here tonight, equality and democracy are under assault," Biden, a Democrat warned, ahead of crucial midterm elections in November that will determine control of Congress.

"Too much of what's happening in our country today is not normal. Donald Trump and MAGA (Make America Great



Again) Republicans represent an extremism that threatens our very republic. MAGA Republicans do not respect the Constitution," the 79-year-old president said, in a rare instance of slamming his prede-

There's no question that the Republican Party today is dominated, driven and intimidated by Donald Trump and the MAGA Republicans," Biden said, referring to Trump's 2016 campaign slogan, Make America Great Again.

"And that is a threat to this country,"

"MAGA forces are determined to take

America where there is no right to choose, no right to privacy, no right to contraception, no right to marry who you love. They promote authoritarian leaders. They fanned the flames of political violence," Biden said. In his 25-minute speech, Biden repeat-

edly called out Trump, who is still questioning the outcome of the 2020 election.

"History tells us that blind loyalty to a single leader and a willingness to engage in political violence is fatal to democracy," he He said he was not condemning all 74

million Americans who voted for Trump in 2020. "Not every Republican, not even a Republicans," he said. Alleging that MAGA Republicans do

not respect the Constitution, Biden called them "insurrectionists and election deniers' who "embrace anger and thrive on chaos"

MAGA Republicans are a "clear and present danger to our democracy," he alleged. They live not in the light of truth

but in the shadow of lies, Biden said.

Former Soviet President Mikhail Gorbachev is set to be buried Saturday in a ceremony falling short of a state funeral that will not be attended by Russian President Vladimir Putin or top international leaders.

The relatively low-key funeral reflects the Kremlin's uneasiness about the legacy of Gorbachev, who has been revered in the West for ending the Cold War but despised by many at home for the collapse of the Soviet Union and the ensuing economic meltdown that plunged millions into

Putin privately laid flowers at Gorbachev's coffin on Thursday because of what the Kremlin described as the pres-

ident's busy schedule that would prevent him from attending the funeral.

Asked what specific business will keep Putin busy, Kremlin spokesman Dmitry Peskov said in a conference call with reporters that the president will have a series of working meetings, an international phone call and must also prepare for attending a business forum in Russia's Far East next

Gorbachev, who died Tuesday at the age of 91, will be at Moscow's Novodevichy cemetery next to his wife, Raisa, following a farewell ceremony at the Pillar Hall of the House of the Unions, an iconic mansion near the Kremlin that has served as the venue for state funerals since Soviet times.

बीते कुछ वर्षों में औद्योगिक निवेश के लिए ग्रेटर नोएडा की तरफ उद्यमियों का रुझान तेजी से बढ़ा है। देश व विदेशों की कई कंपनियां ग्रेटर नोएडा में जमीन पाने के लिए आत्र हैं। उनकी मांग को देखते हुए ग्रेटर नोएडा प्राधिकरण आठ नए औद्योगिक सेक्टर बसा रहा है। इसके लिए करीब 900 हेक्टेयर जमीन खरीद रहा है। अब तक आधी से अधिक जमीन खरीद चुका है। शेष जमीन खरीदने के लिए प्राधिकरण गांवों में शनिवार से शिविर लगाएगा। शिविर का शेड्यूल जारी कर दिया गया है।

एसीईओ दीप चंद्र ने बताया कि ग्रेटर नोएडा प्राधिकरण आठ नए सेक्टर ईकोटेक 7, 8, 9, 12ए, 16, 19, 19, और ईकोटेक 21 बसा रहा है। इन सेक्टरों के लिए प्राधिकरण करीब 900 हेक्टेयर जमीन का इंतजाम किया जा रहा है। इन सेक्टरों के बसने से उद्यमियों को जमीन मिल सकेगी। ग्रेटर नोएडा प्राधिकरण के सीईओ व मेरठ मंडलायक्त सरेन्द्र सिंह के निर्देश पर किसानों से आपसी सहमति के आधार पर जमीन शीघ्र प्राप्त करने के लिए गांवों में शनिवार से शिविर लगाया जाएगा। उन्होंने बताया कि आज सुबह 11 से शाम पांच बजे तक कैलाशपुर के प्राथमिक विद्यालय में शिविर लगाया जाएगा। 10 को आमका के प्राथमिक विद्यालय में, 17 को पहांट क अ। इसके

### गैंगस्टर मामले में श्रीकांत की जमानत याचिका खारिज

गौतमबुद्ध नगर की एक अदालत ने शुक्रवार को नेता श्रीकांत त्यागी की जमानत अर्जी खारिज कर दी। पिछले महीने नोएडा की एक महिला के साथ मारपीट और अपशब्द कहने वाले कथित वीडियो के सामने आने के बाद त्यागी को गिरफ्तार किया गया था।

आदेश की प्रति के अनसार, जिला एवं सत्र न्यायालय के विशेष न्यायाधीश (गैंगस्टर अधिनियम) रणविजय प्रताप सिंह ने जमानत याचिका खारिज कर दी। त्यागी के वकील सुशील



है। नोएडा पुलिस ने त्यागी (34) को नौ अगस्त को मेरठ से गिरफ्तार किया था और उसके खिलाफ गैंगस्टर अधिनियम और असामाजिक गतिविधियां (रोकथाम) अधिनियम के तहत मामला दर्ज किया गया था। गैंगस्टर अधिनियम के अलावा त्यागी पर प्रतीक का उपयोग करने के आरोप में धोखाधडी का मामला भी दर्ज किया गया था, जो केवल विधानसभा सदस्यों को जारी किए जाते हैं।

बता दें कि पांच अगस्त को नोएडा की ग्रैंड ओमेक्स सोसाइटी में महिला से बदसलूकी को लेकर श्रीकांत त्यागी के खिलाफ आईपीसी की धाराओं 354, 420 और गाली-गलौज के मामले में केस दर्ज हुआ था। समाजवादी पार्टी का एक प्रतिनिधिमंडल श्रीकांत त्यागी के परिजनों से मिलने नोएडा पहुंचा। सपा के इस प्रतिनिधिमंडल में 9 सदस्य थे। इस दौरान सोसाइटी के बाहर बड़ी संख्या में पुलिस बल तैनात था।
