EB-5 Golden Opportunity for Indian investors:U.S. Attorney

Chennai, Sep 5: U.S.-based immigration attorney Nadadur Kumar, speaking at Taj Coromandel, Chennai, said now is the best time for Indian nationals to consider the EB-5 Immigrant Investor Program.

Clarifying that a U.S. Green Card does not

require giving up Indian citizenship, he explained that investors can retain flexibility through re-entry permits. With the current EB-5 backlog for Indians shorter than usual, he termed it a “rare, golden opportunity” that will not last as demand rises.

Kumar noted that rising

wealth, property values, and the progress of H-1B and F-1 visa holders have fueled Indian demand. He cautioned families against risky loan-based EB-5 schemes, urging direct investment of the required USD 800,000 (Rs.6–7 crore) to ensure compliance with the two-year

job creation mandate.

He stressed that EB-5 laws remain stable despite shifting enforcement practices, and advised prospective investors to exercise due diligence in choosing advisors and regional centers. “Be alert and you won’t be hurt,” he remarked.
