Pursuant to the aforesaid allotment of equity shares, the issued and paid-up equity share capital of the Company stands increased to Rs. 11,94,17,060/- (Indian Rupees Eleven Crores Ninety Four Lakhs Seventeen Thousand and Sixty) divided into 5,97,08,530 (Five Crores Ninety Seven Lakhs Eight Thousand Five Hundred Thirty) equity shares of the face value of INR 2/- (Indian Rupees Two) each.
