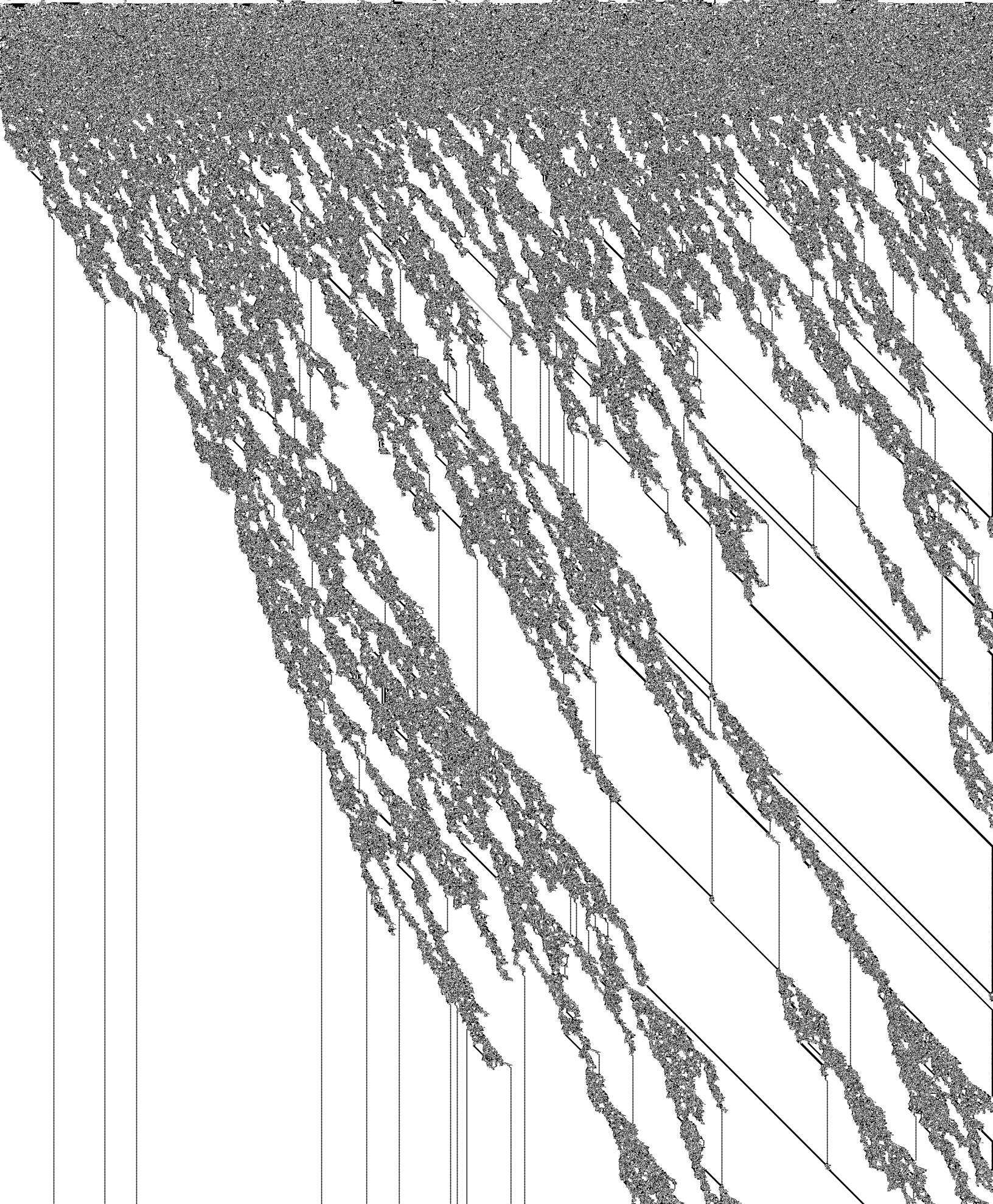

Varhadkar, who was then a police inspector at Raigad police station. The 2018 case was closed after police submitted a closure report in court in April 2019, which was accepted by the court.
