Digital evidence in voter deletion case recovered, says SIT

A SPECIAL investigation team (SIT) of Karnataka CID has informed a special court in Bengaluru that it has recovered the entire digital evidence with regard to the filing of fake voter deletion applications for the Aland constituency in the Kalaburagi district ahead of the 2023 Karnataka elections.

The special court for cases against elected representatives has taken note of the investigation records in the alleged Aland vote theft case in the course of granting anticipatory bail to the former BJP MLA of the constituency Subhash Guttedar, 74, his son Harsha Guttedar and a contractor associate Tippana. "Only if prima-facie materials are found, which would warrant the active involvement of the petitioners, the discretionary relief of anticipatory bail can be granted," the special court has stated in an October 31 order granting anticipatory bail to Subhash Guttedar, his son and aide.

"Even otherwise, the question of tampering with the documents does not arise since as per the prosecution case, the entire materials are available on

a digital platform which has been recovered by the investigating agency," the special court noted in its order on Friday.

"That apart, if the applications were allegedly filed through digital platforms and if the submission of the prosecution that they are analysing the digital records are to be accepted, it indicates that the petitioners cannot be made to undergo incarceration till the completion of investigation," the special court has noted.

The special court was provided with the case diary by the SIT in the Aland illegal vote deletion case last week on the directions of the court. The court sought the case diary to understand the cause of delay in the investigation of the case which was registered in February 2023.

"On taking a cursory look into the materials...nowhere it is indicated that the petitioners were directly involved in the above case," the court noted in its anticipatory bail order.

The SIT has recovered multiple laptops which were used by operatives at a data centre in the Kalaburagi city after being allegedly contracted to delete names of genuine voters in the Aland constituency.

GIFT city campus a 'significant investment': Queen's University Pro VC

CALLING the dip in the number of foreign students in UK universities a 'challenging time', Professor Margaret Topping, Queen's University Belfast's (QUB) Pro Vice-Chancellor for Global Engagement, told The Indian Express that QUB's first international campus in GIFT City is a "very significant investment" as "an aspiration of setting up the campus in India focused on a long collaboration with universities in India".

When asked about UK universities seeing a decline in foreign students, especially from India - as new immigration policies prevent most Master's students from bringing family members - Topping said, "It is a challenging time for UK universities. But in terms of our rationale for opening up campus in India, it is not a direct consequence of the changes in student mobility flows. That's not why we are doing what we are doing. I think that's evidence that we think that we are operating at GIFT City in a very different way from a lot of (foreign) universities. We are not taking a floor in a building, we are taking a whole building,

we have made a very significant investment in this."

QUB - the first UK university to set up an international branch campus in GIFT City starting January 2026 - will launch two dedicated Masters programmes in Artificial Intelligence (AI) in the second cohort. They will be launched in September 2026. YES it would also be the first international campus by QUB ever. Founded in 1848 as Queen's College Belfast, it became an independent university in 1908. It is one of the oldest universities in the UK and Ireland. QUB will be the largest foreign university in GIFT City, launching with 200-250 seats across three Masters programmes.

"There are two programmes we were proposing to offer with an Artificial Intelligence focus. One course is AI for computer science students, the other is AI for Business. While the first would look into the technology aspect, the second would look at how businesses engage with, interact with and introduce ethical frameworks around these of AI in the business sector. We would be hoping to recruit up to 80 to 100 for each of those courses," Prof Topping said.

PM reaches out to women, says NDA on course for record win

Shah, Rajnath, Nadda address election rallies

ON THE last day of the campaigning for the first phase of Bihar elections on November 6, Prime Minister Narendra Modi lauded the women workers of the party for their contribution in strengthening the NDA, urging them to turn out in big numbers to ensure a mega win for the alliance.

A battery of party's senior leaders, including Home Minister Amit Shah, Defence Minister Rajnath Singh, party chief JPNadda, also addressed rallies

in Bihar in which they drew comparisons between 'Jungle raj' when the RJD was in Bihar and the development the state has witnessed under NDA rule.

"The people of Bihar have made up their mind; they will break the last 20 years' record of the NDA's victory...only the NDA can develop Bihar to its full potential," the Prime Minister said during his virtual interaction with women workers at a part of the 'Mera Booth Sabse Mazboot' programme through the NaMo app.

Only an NDA government is the guarantee of a bright future for the women of Bihar," he said. Attacking the RJD-Congress combine over the issue of women's safety, the PM said that during the era of 'Jungle raj', it was difficult for women to step out of their homes, but now

that is not the case. "Now, women walk fearlessly in hospitals, railway stations and other places even during night hours," Modi said.

Union Home Minister Amit Shah, who addressed rallies in Mithila and Bettiah, warned "Pakistan-sponsored terrorists to refrain from further attacking India, asserting that if they repeat the mistake, 'gol ka jawaab se diya jayega' (they will face cannons for bullets)."

In his speeches at Vaishali and Patna, Defence Minister Rajnath Singh said there is not a single corruption case against Bihar CM Nitish Kumar, asserting that only the NDA can make Bihar 'viksit'.

CM forced people to be labourers across India: LoP

AS CAMPAIGNING concluded for the first phase of the Bihar elections, Leader of Opposition (LoP) Rahul Gandhi alleged Tuesday that lower castes, tribal communities and minorities have little representation in private firms, the judiciary, the bureaucracy and the Armed Forces, and that people from "10 per cent" of the population control these institutions.

Gandhi was speaking at a rally in Kumbha seat, where Bihar Congress chief and MLA Rajesh Kumar will face Lalan Ram of HAM(S). Gandhi also addressed rallies in Aurangabad and Wazirganj. The Congress leader said in Kumbha: "If you look at the country's population, then you will see that nearly 90 per cent people are Dalit, Mahadalit, backward, most backward, tribals or minorities. But if you see companies owned by Am-

banian and Adani and if you take out a list of the 500 biggest companies, you should find these communities represented. You will not find one. All hail from the 10 per cent of population. All bank money goes to them, they get a place in the bureaucracy. You should see the judiciary. They have control in the Army too. You will not find the 90 per cent anywhere."

Gandhi also targeted PM Narendra Modi, claiming he is "indifferent towards education because he has a fake degree".

Bihar CM Nitish Kumar, the Congress MP alleged, has "forced the people of the state to become labourers across India".

In Aurangabad, Gandhi claimed Modi was promoting social media "addiction" among youth to distract them from the pressing issues of education, health and jobs.

Also on Tuesday, RJD leader Tejashwi Yadav promised farmers ₹300 per quintal of paddy and ₹400 per quintal for wheat as a bonus over MSP.
